

RESOLUTION TO CORRECT RESOLUTION APPROVED BY CITY COUNCIL ON MAY 19, 2015 CALLING FOR A RUNOFF ELECTION ON JUNE 13, 2015 FROM THE 2015 GENERAL ELECTION IN THE CITY OF EL PASO FOR THE ELECTION OF OFFICERS.

WHEREAS, City Council approved a Resolution on May 19, 2015, calling for a Runoff Election on June 13, 2015 from the 2015 General Election in the City of El Paso for the election of officers.

WHEREAS, it was the intent of City Council not to include Sunday, June 7, 2015 as an early voting day.

WHEREAS, due to clerical error, there was conflicting language in the Resolution.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Early voting shall be held weekdays from Monday, June 1, 2015, through Tuesday, June 9, 2015. There is **NO** voting Sunday, June 7, 2015. The hours for early voting at each early voting location are as noted below.
