A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO, TEXAS, CALLING FOR THE 2017 GENERAL ELECTION IN THE CITY OF EL PASO, TO BE HELD ON MAY 6, 2017, TO FILL THE EXPIRED TERMS OF THE MAYOR, FOUR DISTRICT REPRESENTATIVES, FIVE MUNICIPAL COURT JUDGES, AND THE JUDGE OF THE MUNIPICAL COURT OF APPEALS; AND MAKING PROVISIONS FOR THE CONDUCT OF THE ELECTION; AND AUTHORIZING A CONTRACT WITH EL PASO COUNTY TO FURNISH ELECTION SERVICES AND EQUIPMENT.

WHEREAS, pursuant to the Texas Election Code, as amended, and the City of El Paso Charter, an election will be held on Saturday, May 6, 2017 in the City of El Paso, Texas for the purpose of electing the following officers of the City of El Paso: the Mayor, four District Representatives from Single-Member District Nos. 2, 3, 4 and 7, and the Judges of the Municipal Court Nos. 1, 2, 3, 4 and 5, and the judge of the El Paso Municipal Court of Appeals; and

WHEREAS, by this Resolution, it is the intention of the El Paso City Council to adopt all requirements of this election order in accordance with state law, and to authorize a contract with El Paso County for election services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO THAT:

<u>SECTION 1 – OFFICIAL POSITIONS TO BE FILLED</u>

A general election of the City of El Paso is hereby called to elect the Mayor; one City Council Representative for, respectively, District Nos. 2, 3, 4 and 7; one Municipal Judge for, respectively, Municipal Court Nos. 1, 2, 3, 4 and 5, and one Municipal Court of Appeals Judge. Such election shall take place on the May 6, 2017 uniform election day.

Such election shall be held in the manner and form prescribed by the laws of the State of Texas. At such election all qualified voters of the City shall be permitted to vote at said election, and shall vote at the polling place designated for the election precinct in which they reside. The candidate receiving a majority of the votes cast for each position shall be declared elected to such office.

Such election shall be held at the precincts and the polling places designated in Exhibit "A" or such other locations as may be designated prior to the election by the El Paso County Elections Administrator or City Clerk, attached hereto and made a part hereof for all purposes, and said polling places shall open at 7 a.m. and remain open until 7 p.m. on the day of the election.

SECTION 2 - ELECTION SERVICES CONTRACT WITH COUNTY

The City Manager is hereby authorized to execute a contract, joint or otherwise, with the El Paso County Elections Administrator for the purpose of having El Paso County furnish all or any portion of the election services and equipment needed by the City Clerk to conduct the election. The contract document and election services provided therein shall conform to Chapter 31, Subchapter D, of the Texas Election Code and all other applicable statutes and laws.

The election services contract shall provide (a) the type of electronic voting equipment to be used for early voting by personal appearance and on election day, (b) notification and training for election judges and clerks, (c) an estimate and final payment terms for the election services provided, (d) agreements for early voting equipment and voting machine rental, and (e) other procedures necessary to conduct the election.

SECTION 3 – EARLY VOTING CLERK

Lisa Wise, El Paso County Elections Administrator, 500 E. San Antonio, Suite 314, El Paso, Texas, 79901, is hereby appointed as Early Voting Clerk. Applications for ballot by mail must be received no later than the close of business on April 25, 2017, sent to this address.

SECTION 4 – EARLY VOTING

Early voting by personal appearance shall be conducted at the El Paso County Courthouse, located at 500 E. San Antonio, El Paso, Texas 79901. In addition, early voting may also occur at such branch early voting polling places as are designated herein or otherwise designated by the El Paso County Elections Administrator and posted at City Hall by the City Clerk. The locations and hours for early voting by personal appearance shall be authorized for such election as set forth in Exhibit "A."

In addition, mobile voting stations may be authorized and used for early voting at publicly owned buildings in the City as established by the El Paso County Elections Administrator. The City Clerk is authorized to make corrections or revisions to the list of these mobile stations, including the respective hours for early voting by personal appearance at these stations. The City Clerk is further authorized to make corrections or revisions to the list of early voting stations as set forth above, including the respective hours for early voting by personal appearance at these stations, and revise and correct all election notices regarding the early voting locations and the mobile voting stations, and the dates and times for such voting.

For purposes of processing ballots cast in early voting, the election officers for the Early Voting Ballot Board shall be appointed and designated in accordance with the provisions of the election agreement with El Paso County.

SECTION 5 - FILING FOR PLACE ON BALLOT

Applications for candidacy to the offices set forth in Section 1 shall be made to the City Clerk of the City of El Paso beginning on January 18, 2017 and ending on February 17, 2017, in the manner and form as prescribed by law.

The names of eligible and qualified candidates for such offices shall be placed on the ballots for such election by the City Clerk at the time and in the manner prescribed by law.

SECTION 6 – VOTING MACHINES AND ELECTION RESULTS

Voting machines used for the conduct of the election, shall be procured, maintained, operated, sealed and the votes therefrom tabulated pursuant to procedures established and authorized by the laws of the State of Texas.

The results of the election shall be certified, canvassed, and returned in the form and manner prescribed by law.

<u>SECTION 7 – NOTICE OF ELECTION</u>

The notice of the election hereby ordered and called shall be promulgated, published and posted in keeping with the state and local laws. A substantial copy of this resolution shall serve as proper notice of said election.

The City Clerk shall give notice of such election by posting a notice of such election in English and Spanish in the Office of the City/Municipal Clerk as provided by law and by publishing a copy of said notice in both English and Spanish in a newspaper in the City as required by law.

The City Clerk shall deliver notice of this election to the county clerk and voter registrar of El Paso County, as required by law.

SECTION 8 - RUNOFF ELECTION

Any runoff election required for the election of the named official City positions, following the general election of May 6, 2017, shall be held on a date that is permitted by and in accordance with Section 2.025 Election Code of the State of Texas. Such election, if any, shall be called by the City Council. Early voting dates and sites will be identified if such runoff election shall be held.

SECTION 9 - COMPLIANCE WITH APPLICABLE LAWS

The City Manager and the City Clerk, in consultation with the City Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of federal and state law in carrying out and conducting the election, whether or not expressly authorized herein.

COUNTY OF EL PASO)	

This CONTRACT FOR ELECTION SERVICES ("Contract") is entered into pursuant to Texas Election Code Sec. 31.091 et seq., by and between the City of El Paso Texas, (the "City of El Paso") and El Paso County, Texas (the "County").

1. RECITALS. City of El Paso is a political subdivision situated wholly within El Paso County, Texas. City of El Paso has scheduled an election for May 6, 2017 and has requested the County to perform election services as provided by and under Election Code Sec. 31.091 *et. seq.* The County and City of El Paso have determined it is in the public interest that the following contract be made and entered into for the purpose of having the County, through its Elections Administrator, furnish to City of El Paso certain election services and equipment needed by City of El Paso on May 6, 2017 in connection with the holding of the May Uniform Election and any resulting runoff election (attached estimate is for May Uniform Election. Additional estimate for runoff will be drafted if needed.).

2. <u>DUTIES AND SERVICES OF CONTRACTING OFFICER.</u>

All services to be performed by the County may be delegated to the County Elections Administrator (the "Contracting Officer"). The County Elections Administrator shall serve as Early Voting Clerk, unless at the time of approval of this Contract, the authority calling for the election appoints a person other than the County Elections Administrator and notifies the County prior to the appointment. The County shall perform the duties and furnish the services and equipment listed below. The County, by and through its Contracting officer, shall:

- (a) Furnish to City of El Paso certain election services and equipment needed by City of El Paso in connection with holding its election on May 6, 2017;
- (b) Provide training of judges, alternate judges, and clerks, including deputy early voting clerks;
- (c) Prepare lists and submit names of persons suggested for appointment as presiding election judges, alternate judges, and judge of the central counting station;

- (d) Prepare lists and submit names of persons suggested for appointment as deputy early voting clerks;
- (e) Serve as manager of the central counting station or appoint a substitute manager;
- (f) Arrange for the use of polling places in the election and runoff election if necessary;
- (g) Program or arrange to have the ballot programmed;
- (h) Procure and distribute necessary election supplies, and distribution of ballots;
- (i) Assemble and edit lists of registered voters to be used in conducting the election, in conformity with the boundaries of CITY OF EL PASO and the election precincts established for the election;
- (j) Procure, prepare, and distribute election equipment, transport equipment to and from the polling places for early voting and Election Day, and issue election supplies to the precinct judges;
- (k) Supervise the conduct of early voting;
- (l) Conduct one or more election schools and notify the election judges and clerks of the time, date, and location of the schools;
- (m) Arrange for use of a central counting station and for the tabulating personnel and equipment needed at the counting station and assist in preparing the programs and test materials for tabulation of the ballots to be used with electronic voting equipment;
- (n) Arrange to publish legal notice of the date, time and place of the testing of the electronic tabulating equipment, and conduct the testing in accordance with Texas Election Code chapters 127.001 et seq. and chapter 129.001 et seq. and in accordance with Texas Secretary of State advisories;
- (o) Supervise the handling and disposition of election returns, voted ballots, and tabulate unofficial returns and assist in preparing the tabulation for the official canvass;
- (p) Provide general information services for voters and election officers:
- (q) Assist in providing general overall supervision of the election;
- (r) Provide for the storage of election records as provided by law;
- (s) Provide CITY OF EL PASO with a precinct by precinct roll of registered voters in a mutually agreed upon format;
- (t) If requested by CITY OF EL PASO, prepare the unofficial tabulation of precinct results on election night;

- (u) Submit election night returns to the Secretary of State, in a format to be described by the Texas Secretary of State and in accordance with Election Code Chapter 68, if applicable; and
- (v) Certify that a criminal background check on all employees, including temporary employees, which may program, test, perform maintenance, transport equipment, or perform technical support on the voting system equipment for CITY OF EL PASO has been performed.

3. <u>DUTIES AND SERVICES OF CITY OF EL PASO</u>.

The CITY OF EL PASO shall:

- (a) Adopt an order appointing the County Elections Administrator as Early Voting Clerk as required above;
- (b) Prepare appropriate documents for establishing the precinct and polling places;
- (c) Prepare all election orders, resolutions, notices, and other pertinent documents for adoption for execution by the appropriate CITY OF EL PASO officer or body, and take all actions necessary under law and in accordance with this Contract for calling the election, appointing the presiding judges, alternate judges, judge of the central counting station, and other election officers, establishing precincts and polling places, handling contests, canvassing the returns and declaring the results;
- (d) Approve the tabulating supervisor and assistants and central counting station manager, recommended by the County Elections Administrator;
- (e) Prepare and publish required election notices as required by law;
- (f) Deliver and certify to the County Elections Administrator as soon as possible, but not later than sixty days before the election, the names, issues, or referenda which are to be printed on the ballot or ballot labels with the exact spelling that is to be used:
- (g) Provide a copy of the ballot language in Spanish. City of El Paso may also be responsible for providing Spanish translations for any notices the District publishes regarding the election;
- (h) Pay any additional costs incurred by the County Elections Administrator if a recount for the election is required, or the election is contested in any manner;
- (i) Return all surplus election supplies to the County Elections Administrator;
- (j) Prepare any submission on voting changes which may be required to be submitted to the US. Department of Justice under the Federal Voting Rights Act of 1965, as amended;
- (k) Pay 75% of the estimated costs attached hereto as Exhibit A no later than ten (10) days before Election Day; and

(l) Pay the balance of conducting the election and additional costs within thirty days from the receipt of an invoice from the County Elections Administrator.

4. <u>COST OF SERVICES.</u>

CITY OF EL PASO shall pay for the above services, supplies and equipment in accordance with the estimated cost schedule attached to this Contract (EXHIBIT A), which is mutually agreed upon.

5. GENERAL TERMS AND CONDITIONS.

- (a) A total of one hundred sixty nine (169) precincts plus twenty one (21) permanent early voting stations, and one hundred thirty one (131) polling locations will be used for conducting the election.
- (b) CITY OF EL PASO acknowledges that the County may enter into similar Contracts for Election Services with other political subdivisions in the same county for the same election date. During early voting a voter will be eligible to vote at any one of the early voting locations and mobile voting locations, if any. CITY OF EL PASO agrees to share common polling places with the other political subdivision(s) as determined by the County and in accordance with the costs as allocated by the County.
- (c) Nothing in this Contract shall authorize or permit a change in the officer with whom, or the place at which, any document is to be filed, the place at which a function is to be carried out, or other nontransferable functions as specified by the Election Code.
- (d) The Elections Administrator shall file a copy of this contract with the County Judge and the County Auditor of El Paso County.
- (e) Neither party may assign, in whole or in part, any interest they may have in the agreement.
- (f) Nothing in this agreement imposes any duty on the County to maintain or repair the facilities or cure any premise defects of the property on which polling locations are located.
- (g) Neither CITY OF EL PASO nor any employee of CITY OF EL PASO is an agent, or employee of the County and neither Elections Administrator nor any employee of the County is an agent or employee of CITY OF EL PASO. This agreement does not and shall not be construed to entitle either party or any of their respective employees, if applicable, to any benefit, privilege, or other amenities of employment by the other party.
- (h) CITY OF EL PASO and the County reserve, and do not waive, their rights of sovereign immunity and similar rights, immunities and rights of their officials and employees, and their employees' and officials' rights under the Texas Tort Claims Act.
- Venue is in El Paso County, Texas.
