#### **BACKGROUND / DISCUSSION:**

The City will utilize offsite fueling locations provided by the vendor, Western Refining, to fuel light and heavy duty vehicles from the Police Department, Fire Department and Mayor and City Council. Approving this contract will allow for the continual fueling of these vehicles as well as safe and efficient operation. Local business is being supported.

#### **SELECTION SUMMARY:**

Exercising this option would meet the following threshold considerations (i) funds available; (ii) requirement fills and existing city need; (iii) informal analysis of price indicates the option price is better than available market prices or the most advantageous current offer, and; (iv) <u>Vendor's</u> performance meets or exceeds a "7-8" performance rating. Based upon our evaluation of above factors, Purchasing Division recommends exercising the available option.


