That the City Manager be authorized to send notice terminating the November 18, 2014 Glory Road Transit Terminal Retail Lease Agreement between the City of El Paso and Sumatra Hookah Lounge LLC, Inc. for the premises at 100 Glory Road, Suite 100, El Paso, El Paso County, Texas.

**BACKGROUND / DISCUSSION:**

The City constructed a retail space at the Glory Road Transit Terminal, also known as GRTT, at 100 Glory Rd. There were multiple goals for these retail spaces. One goal was to create walkable streets with active retail storefronts. Another was to create a non-tax revenue stream to the City and to achieve the highest and best use of the property. The City marketed the space and negotiated a lease agreement to rent the space out to an existing business that was seeking to expand its operations. Due to circumstances outside of our control, the Tenant was unable to fulfill their responsibilities to occupy the space. This is a formal motion to terminate the existing Lease, so that staff may fully market the space and find a suitable tenant for the property.


