Agenda

- Since 2017, \$30.4 million in annual funding to address community priorities
- Budget stabilization fund
- Implementing continuous improvements to identify new revenue and minimize costs



Streets

- \$500,000 annually for ADA on-demand requests since 2016
- \$7 million annually for street maintenance projects approved in summer of 2018
- \$2 million annually for median maintenance for State roads approved in summer of 2019
- \$200,000 annually for neighborhood traffic mitigation projects
- \$3 million annually for street maintenance projects approved December 17, 2019

Public Safety

- •\$4 million annually for Public Safety capital
 - •\$2.3 million for Fire
 - \$1.7 million for Police



Parks and Facilities

- \$1.5 million annually for Sports Complex maintenance
- \$400,000 annually for sport court resurfacing
- \$1.5 million annually for facility maintenance

Economic Development

- \$5 million annually from El Paso Electric franchise fee approved October 2018
- \$5.3 million annually for 15 years once franchise fee ordinance approved (February 2020)

Budget Stabilization Fund

- In December 2015, City Manager recommended creating a budget stabilization fund to offset future tax rate increases
- Recommendation was not accepted by City Council
- On January 7, 2020, staff presented \$5.3 million surplus from FY 2019
- In February, staff will be bringing forward a recommendation for City Council action to allocate FY 2019 savings into a budget stabilization fund

Continuous Improvement and Innovation

- 500+ Employees engaged in the Process Improvement Program
- 100% Departments trained in the Process Improvement Program
- 81% Departments with Process Improvement Program projects
- Lean Six Sigma (LSS) Belts
 - 45 green belts
 - 75 yellow belts
 - 146 white belts


