STATE OF TEXAS § MEMORANDUM OF UNDERSTANDING § COHEN ENTERTAINMENT DISTRICT, PHASE 1 ("CED1")

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made and entered into effective as of the \_\_\_\_\_ day of \_\_\_\_\_ by and between the CAPITAL IMPROVEMENT DEPARTMENT ("CID") of the CITY OF EL PASO ("CITY"), a Texas home rule municipal corporation, and the EL PASO WATER UTILITY PUBLIC SERVICE BOARD, a component of the City of El Paso, whose Board of Trustees is vested with management and control of the City of El Paso water and wastewater system ("UTILITY", "PSB" OR "EPWater"), (individually, a "Party" and collectively, the "Parties"), for the purposes described herein.

#### WITNESSETH

WHEREAS, Section 15020.070 of the Texas Government Code allows a municipality to vest the management and control of the municipal utility system in board of trustees; and,

WHEREAS, the El Paso City Council adopted Ordinance 752 establishing the El Paso Water Utilities Public Service Board and delegated to the PSB the authority to manage and control the municipal utility system; and,

WHEREAS, There is an entertainment district development which will include District 04's water park known locally as the COHEN ENTERTAINMENT DISTRICT PHASE 1 ("CED1"), to be located at 9700 Gateway North Blvd. El Paso, Texas 79924 and more particularly described in Exhibit A ("SITE"); and

WHEREAS, the Parties contemplate the construction of a 8-inch water line and 12-inch wastewater line ("PROJECT"), more particularly described MOU in Exhibit B ("PROJECT SCOPE"), that must be installed along an access 30-foot right-of-way to the Site and within a 20-foot wide parcel of land in order to allow proper development of the CED1 as shown on Exhibit C.; and

WHEREAS, the Parties agree that the Project work be coordinated and accomplished in accordance with the terms of this MOU in order that the Project shall proceed expeditiously and that the responsibilities of the Parties shall be as set forth herein; and

NOW THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the Parties hereto, to be by them kept and performed as hereafter set forth, CID and Utility do agree as follows:

#### **AGREEMENT**

#### 1. Time Period Covered

This MOU becomes effective upon the date first written above, and CID and EPWater will

consider it to be in full force and effect until the Project described in this MOU has been completed and accepted by all Parties or unless terminated, as provided herein.

## 2. Responsibilities of the Parties

#### A. Utility Responsibilities

- i. EPWater shall provide engineering services for water & wastewater line to the site.
- ii. Upon completion of the water & wastewater line in accordance with appropriate installation and testing; and upon acceptance by EPWater together with receipt by EPWater of Contractor's Waiver of Lien affidavit, along with the Certificate of Final Completion (attached to this MOU as "MOU Attachment A") executed by CID, the lines will be incorporated into EPWater's systems and maintained by EPWater subject to the usual one-vear warranty from CID's General Contractor.

## B. CID Responsibilities

- i. CID shall pay to EPWater the standard engineering fee of 2% of EPWater's estimated cost for the lines. The estimated cost of the water line is \$27,519.69, wastewater line is \$82,475.42 and resulting in an estimated engineering fee of \$2,199.90.
- ii. Payment of the engineering fees shall be made prior to the release for construction of the facilities and 30 days after presentation to CID by EPWater of an invoice for services performed.
- iii. It is understood and agreed that CID shall have the water and wastewater line constructed in accordance with EPWater-approved plans and specifications. EPWater will provide inspection services during the installation of the project. CID shall be responsible to pay its chosen General Contractor for the construction costs for the line extensions and appurtenances.
- iv. In order to facilitate the inspection, testing, and anticipated acceptance of the water and wastewater line and appurtenances; CID shall have its General Contractor provide to EPWater all construction reports and a videographic survey of the constructed water and wastewater line.
- v. It shall be the responsibility of the City to pay for all costs associated with providing water and wastewater service to the Site to include all costs for fees.
- vi. The water main to serve the Site will be installed along an access 30-foot

right-of-way and the wastewater main to serve the Site will be within a 20-foot wide parcel of land and an access 30-foot right-of-way. (Exhibit C)

#### 3. Termination

This MOU may be terminated in the following manner:

- A. By mutual written agreement and consent of both Parties; or
- B. By either Party upon the failure of the other Party to fulfill the obligations set forth in this MOU.

If the MOU is terminated in accordance with the above provisions, CID will be responsible for the payment of costs incurred by EPWater on behalf of CID up to the time of termination.

## 4. Responsibilities of the Parties

Both Parties acknowledge that neither is an agent, servant, employee of the other, nor are the Parties engaged in a joint enterprise, and each Party is responsible for its own acts and deeds and for those of its agents or employees during the performance of the work on the Project.

#### 5. Governmental Function

Both Parties expressly recognize that the other is performing a governmental function in pursuing their respective responsibilities under this MOU.

## 6. Sole Agreement

In the event the terms of this MOU are in conflict with the provisions of any other existing agreements between the EPWater and CID, the latest agreement shall take precedence over the other agreements in matters related to the Project.

## 7. Successors and Assigns

CID and EPWater each binds itself, its successors, executors, assigns, and administrators to the other Party to this MOU and to the successors, executors, assigns, and administrators of such other Party in respect to all covenants of this MOU.

#### 8. Amendments

By mutual written consent of the Parties, the scope of work and payment provisions of this MOU may be amended prior to its expiration.

## 9. Inspection and Conduct of Work

Unless otherwise specifically stated in this MOU, CID will supervise and inspect all work performed hereunder and provide such engineering inspection and testing services as may be required to ensure that the Project is accomplished in accordance with the approved PS&E documents provided by the EPWater. All correspondence and instructions to CID's selected Project contractor performing the work will be the sole responsibility of CID.

#### 10. Maintenance

Upon completion of the Project and acceptance by the Utility, the Utility will assume responsibility

for the maintenance of the completed Utility facilities unless otherwise specified in this MOU. CID shall require the contractor to provide a one-year warranty from the date of acceptance by the Utility.

#### 11. Notices

All notices to either Party by the other required under this MOU shall be delivered personally, via Inter-Departmental Mail, or sent by U.S. mail, postage prepaid, addressed to such Party at the following addresses:

## 12. Severability

If any provision of this MOU shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof, but rather this entire MOU will be construed as if not containing the particular invalid or unenforceable provision(s), and the rights and obligations of the Parties shall be construed and enforced in accordance therewith. The Parties acknowledge that if any provision of this MOU is determined to be invalid or unenforceable, it is their desire and intention that such provision be reformed and construed in such a manner that it will, to the maximum extent practicable, give effect to the intent of this MOU and be deemed to be validated and enforceable.

#### 13. Venue

For any and all disputes arising under this MOU, venue shall be in El Paso County, Texas.

## 14. Signatory Warranty

Each signatory warrants that the signatory has necessary authority to execute this MOU on behalf of the entity represented.




