Pilot Program Background Summary

- **October 2018** - received inquiries from companies
 - Staff began drafting into rules and regulations to permit them
- **November 2018** - met with the inquiring providers (3) to discuss proposed rules and regulations
 - Recommendations taken into consideration
 - # of permit holders (3) and the maximum # of deployed devices (200 each) based on feedback and research/experience from other cities
- **January 8, 2019** - City Council adopted Ordinance establishing the 12-month Pilot Program
 - Authorized City Council to establish fees
 - Gave authority to the Director to adopt and amend the rules and regulations to address trends, improvements or issues through the duration of the Pilot

Schedule C Amendment

Shared Mobility Devices

ITEM DESCRIPTION: A Resolution amending Schedule C to establish new fees authorized under Section 15.08.150. The fees are proposed for the placement of shared use mobility devices on the City right-of-way.

The proposed amendment to Schedule C reflects the fees for Shared Mobility Devices found in the proposed rules and regulations to be adopted and amended by the Director. This item is related to the Title 15 Amendment for a 12-month pilot program for Shared Mobility Devices, which City Council adopted an Ordinance to create Section 15.08.150, Shared Mobility Devices, on January 8, 2019 which gave City Council authority to adopt fees regarding Shared Mobility Devices.

Pilot Program Fees

Application Fee: \$371

Permit Fee: \$21 per device

Exhibit B-Original Proposed Fee *(from previous agenda item backup-Proposed Rules and Regulations)*

Description	Fee	Purpose/Covers costs associated with:
Application Fee	\$371	Application Review
Permit Fee	\$1/day per device; or Per-Trip Surcharge of \$0.25 for each booked trip	Fund improvement and installation of shared use mobility infrastructure
Annual Fee	\$50 per device	Analyzing and assessing data, responding to public complaints, cover costs associated with: removing broken, damaged and/or incorrectly parked vehicles if the company cannot or will not themselves; the purchase and installation of shared use mobility infrastructure

Exhibit C-Revised Proposed Fee *(Proposed Rules and Regulations to be revised)*

Application Fee: \$371

Permit Fee: \$0.55/day per device
