It is requested that the City Manager be authorized to establish the funding sources and make any necessary budget transfers and execute any and all documents necessary for execution of this award.

Work under this unit price contract is only an estimated value and will be ordered, performed, invoiced, and paid by measured quantity. The actual cost of this contract may be higher or lower than the total estimated value and will be the sum total of unit prices at the end of the contract term.

As a part of this award, upon the review of the City Attorney, the City Engineer may without further authorization from City Council approve contract changes which are necessary for proper execution of the work and carrying out the intent of the project, which are in accordance with applicable law, do not make changes to the prices and are within the appropriate budget.

This is a low bid, unit price contract. The Engineering & Construction Management Department recommends award as indicated to the lowest responsive and responsible bidder.

**BACKGROUND / DISCUSSION:**

The resurfacing project includes replacing existing asphalt surface of the road with a new asphalt surface to the original grade of the street, which includes providing pedestrian path of travel and the removal of barriers to meet current ADA standards. The project also includes repairing structurally failed curbs, repairing sections of sidewalk that is not passable and installing concrete aprons around any penetrations in the asphalt surface such as manholes, water meters and monuments. This contract will address streets are selected solely on the criteria of the asphaltic surface condition (Pavement Condition Index Rating) that rank them within the currently approved CIP funding.



# **STREET RESURFACING 2015**

## **SOLICITATION No. 2015-433**

### **SCOPE OF WORK**

The City of El Paso intends to produce a street resurfacing program that will provide a new riding surface to the selected streets as well as updating the pedestrian elements of the selected streets and replacing damaged concrete parkway structures. This project will accomplish this goal using the following processes:

#### **CRUSHED AGGREGATE BASE COURSE REPAIR**

This item shall consist of a base course composed of crushed aggregates constructed on the underlying surface in accordance with specifications and shall conform to the dimensions and typical cross section of original design of the existing roadway and with the lines and grades approved by the Transportation Director or his/her designated representative.

#### **COLD MILLING**

This portion of the project consists of wedge milling at various inch depths of streets throughout the City of El Paso, Texas. The Contractor will mill the existing pavement within the designated limits for each location and transition it to match the existing pavement at a minimum width of 5 feet.

#### **HEATER SCARIFYING/RECYCLING/REJUVENATING AGENT**

This portion of the project consists of heater scarifying and recycling of worn bituminous pavements.

#### **PAVING**

The Contractor will place on a prepared surface SMAR or SMA overlay at the specified thickness for each location.

## **RIGID PVC (POLYVINIL CHLORIDE) CONDUIT AND GROUND BOXES**

This item will consist of the installation of 3 inch PVC conduit, 2 inch PVC conduit, type A ground boxes, and type C Ground boxes on various Street locations throughout the City of El Paso, Texas.

## **SPECIAL TRAFFIC CONTROL**

This item will consist of placing the necessary traffic control devices, light plants, and personnel for work on various Street locations throughout the City of El Paso, Texas.

## **CONCRETE APRONS FOR CIRCULAR PENETRATIONS IN ASPHALT PAVEMENTS**

This item will consist of raising all utility encasements and/or City monuments to the grade of the paved surface, with eight (8) inch reinforced utility aprons around the utility encasement and/or City monument on various Street locations throughout the City of El Paso, Texas.

## **RISER RINGS FOR UTILITY ENCASEMENTS/AND OR CITY MONUMENTS**

This item will consist of the installation of man-hole raiser rings on storm sewer man holes, water valves and/or city monuments throughout the City of El Paso, Texas.

## **ADJUSTMENT OF WATERVALVE AND/OR CITY MONUMENTS AND STORM AND/OR WASTE WATER MAN HOLES**

This item will consist of adjusting to grade water valves and/or City monuments, storm sewer and/or waste water sewer man holes throughout the City of El Paso, Texas.

# Contract Scope

- The contract is the primary tool for implementing the **Year 3** Street Resurfacing projects of the Seven Year CIP plan for Street Infrastructure.
- During **Year 1** the Department completed a \$3.3 million street resurfacing project in the northeast section of the city (District 4); this contract focused primarily in the east side/mission valley areas.
- During **Year 2** the department executed a \$7,776,950 Street Resurfacing project focused in Districts 3, 6 & 7; this project is approximately 48% completed.
- Work on this award shall include:
  - Site preparation
  - Milling and replacement of the asphalt street surface
  - Repair of broken concrete elements within the street right of way
  - Installation of ADA compliant accessibility ramps where feasible
  - Application of thermoplastic street lane lines and markings where feasible

**This is a low bid, Unit Price Contract.**



# Use of Rubberized Asphalt

- In 2014 EPDOT changed its street resurfacing specification to utilize performance grade stone matrix asphalt rubber (commonly referred to as rubberized asphalt)
- This will be the second street resurfacing project contract to utilize rubberized asphalt
- Benefits of rubberized asphalt, as identified in a Clemson University study, include:
  - Reduces Reflective Cracking in Asphalt Overlays
  - Reduces Maintenance Costs
  - Improves Resistance to Cracking in New Pavements
  - Improves Resistance to Rutting in New Pavements
  - Increases Pavement Life
  - Improves Skid Resistance
  - Decreases Noise Levels
  - Beneficially Uses 500-2,000 scrap tires per lane mile
