The amendment value is not to exceed \$50,000.

AGREEMENT

COUNTY OF EL PASO ) FOR PROFESSIONAL SERVICES

This Second Amendment to that certain Agreement for Professional Services is made this day of \_\_\_\_\_\_, 2015, by and between the City of El Paso, a Texas municipal corporation (the "Owner"), and SWA Group, (the "Consultant").

**WHEREAS**, on June 12, 2012, the Owner entered into an Agreement for Professional Services (the "*Agreement*") with the Consultant for a Project known as "San Jacinto Plaza Redesign" (the "*Project*");

WHEREAS, the Agreement may be amended under the provisions of Section 3.2 and Attachment "C"; and

WHEREAS, the Agreement further provides that the City Engineer may authorize additional services in an amount not to exceed \$50,000.00; and

**WHEREAS**, on December 4, 2014, the Owner and Consultant entered into a First Amendment to the Agreement to provide additional services for design coordination at an additional cost of \$50,000.00 thereby extending the contract amount from \$500,000.00 to \$550,000.00 pursuant to the City Engineer's authority; and

WHEREAS, the parties hereto desire to enter into a second amendment to the Agreement to provide additional services for construction observation, which includes but is not limited to, review of submittals and shop drawings, answering Requests for Information, and conduct site visits to inspect the Project's canopy and other amenities, at an additional cost of \$50,000, thereby extending the contract amount from \$550,000.00 to \$600,000.00.

**NOW THEREFORE**, in consideration of the mutual promises set forth in this Amendment and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Scope of Services</u>. The Owner hereby authorizes the Consultant to continue to perform the Services as described in Attachment "A" of the Agreement as well as perform the additional services as further described in Attachment "A" to this Second Amendment.
- 2. <u>Payments to Consultant</u>. Payments to the Consultant shall be made pursuant to the schedule enumerated within Attachment "D" of the Agreement. Payment to the Consultant for the additional services the subject of this Second Amendment shall not exceed Fifty Thousand and 00/100 Dollars (\$50,000.00).

- 3. <u>Time of Completion</u>. The additional services the subject of this Second Amendment shall be completed within the original project schedule as set forth in the Agreement, following the Owner's written Notice to Proceed to the Consultant.
- 4. <u>Terms and Conditions</u>. All terms and conditions of the Agreement and all subsequent Amendments thereto, except as herein revised, shall remain in full force and effect.

# **Background**

- Voters approved reconstruction of San Jacinto Plaza on November 6, 2012.
- Design was required to reconstruct San Jacinto Plaza
- City Council awarded design contract to SWA Group,
   Inc.
- Funded by 2012 Quality of Life Bonds
- District No. 8



# **Previous Council Action**

- Council approved the original Agreement for Professional Services between the City and SWA Group, Inc. on June 12, 2012. The services included basic services for design and preparation of construction drawings. Not included was consultant services during construction. The agreement was for \$500,000 with the City Engineer having the authority to authorize additional services not to exceed \$50,000.
- On December 4, 2014 City Engineer authorized a first amendment in the amount not to exceed \$50,000 for consultant services during construction phase services.



# **Scope of Work**

- Additional consultant services during construction
- Includes reviewing submittals and shop drawings
- Site visits to inspect Los Lagartos canopy and other amenities
- Respond to contractor's questions on design
- Amendment value is a not to exceed \$50,000
