WHEREAS, on January 8, 2013, the City entered into a contract with Contractor through the U.S. General Service Administration Council Cooperative (GSA) Contract #GS-35F-0692P for the purchase of a Mass Notification System and annual system maintenance services for an initial term of three (3) years (the "Contract"); and

WHEREAS, the Assignor and Assignee, as governmental units, decided that the transfer of the maintenance and management of the Mass Notification System to the Assignee benefits both entities and serves a governmental purpose of enhancing the health and safety of the local population by providing public warning and notification; and

WHEREAS, Assignor and Assignee desire to enter into this Consent to Assignment of the Contract with Everbridge in order to transfer the maintenance and management of the Mass Notification System to Assignee; and

WHEREAS, Assignee has agreed to be responsible for all duties and obligations under the Contract; and

WHEREAS, the Contractor agrees to the assignment of all rights, duties and obligations encompassed in the Contract to Assignee.

NOW, THEREFORE, IT IS HEREBY AGREED as follows:

- Everbridge consents to the assignment of the rights, duties and obligations under the Contract to Assignee.
- 2. Assignee agrees to assume and perform all duties, obligations and responsibilities under Contract.
- Assignor is released from all duties, obligations, and responsibilities under the Contract.
- 4. All terms and conditions of the Contract shall remain in full force and effect.
