**SUBJECT:**

Via Ordinance, amend Title 12, Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVIII – Restrictions on parking in residential districts), Paragraph U (No Parking 9:00 A.M. to 10:00 P.M., everyday) to add N. El Paso Street from W. Rio Grande Avenue to E. Yandell Drive, the penalty being as provided in Section 12.84.010 and 12.44.280 (S) of the El Paso City Code.

**BACKGROUND / DISCUSSION:**

Streets and Maintenance received a request from a constituent to expand the existing Residential Parking District, Zone U to include their property. Due to the close proximity to El Paso Community College Rio Grande Campus and the Southwest University Ballpark, parking and congestion burdens from park patrons and students are causing these residents to park blocks away from their home.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.200 (SCHEDULE XVII-RESTRICTIONS ON PARKING IN RESIDENTIAL DISTRICTS), SUBSECTION (ZONE U) (NO PARKING, 9:00 A.M. TO 10:00 P.M., EVERYDAY) TO ADD N. EL PASO STREET FROM W. RIO GRANDE AVENUE TO E. YANDELL DRIVE. THE PENALTY BEING PROVIDED IN SECTION 12.84.010 AND 12.44.280 (S) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVII-Restrictions on parking in residential districts), Subsection (Zone U) (No parking, 9:00 a.m. to 10:00 p.m., everyday) is hereby amended in its entirety to read as follows:

1. Beginning at the intersection of the centerline of West Yandell Drive with the southeast curbline of Fewel Street;
  - Thence southwest along the northeast curbline of Fewel Street to its intersection with the northeast curbline of Mundy Drive;
  - Thence northwest along the northeast curbline of Mundy Drive to its intersection with the west curbline of Lawton Drive;
  - Thence south along the west curbline of Lawton Drive to its intersection with the south curbline of Missouri Avenue;
  - Thence west along the south curbline of Missouri Avenue to its intersection with the east curbline of Porfirio Diaz Street; and
  - Thence south along the east curbline of Porfirio Diaz Street to its intersection with the northeast curbline of Main Street;
  - Thence east along the north curbline of Main Street/Interstate Highway 10 to its intersection with the northeast curbline of Yandell Drive;
  - Thence northwest along the northeast curbline of Yandell Drive to the point of beginning.

2. N. El Paso Street from W. Rio Grande Avenue to E. Yandell Drive.

**Section 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
