Purpose of Requested Amendment

Ordinance Amending Title 12.88.200

Action Requested by a Resident:

- **Expand Existing Residential Parking District (RPD) Zone U: No Parking 9:00am-10:00pm everyday**
- Property owners adjacent to this street segment support this parking restriction
- Parking and congestion burdens exist during events at the Southwest University Park and when school is in session at El Paso Community College Rio Grande Campus
- Park patrons and students park in neighborhood forcing residents to find parking spaces away from their residence.

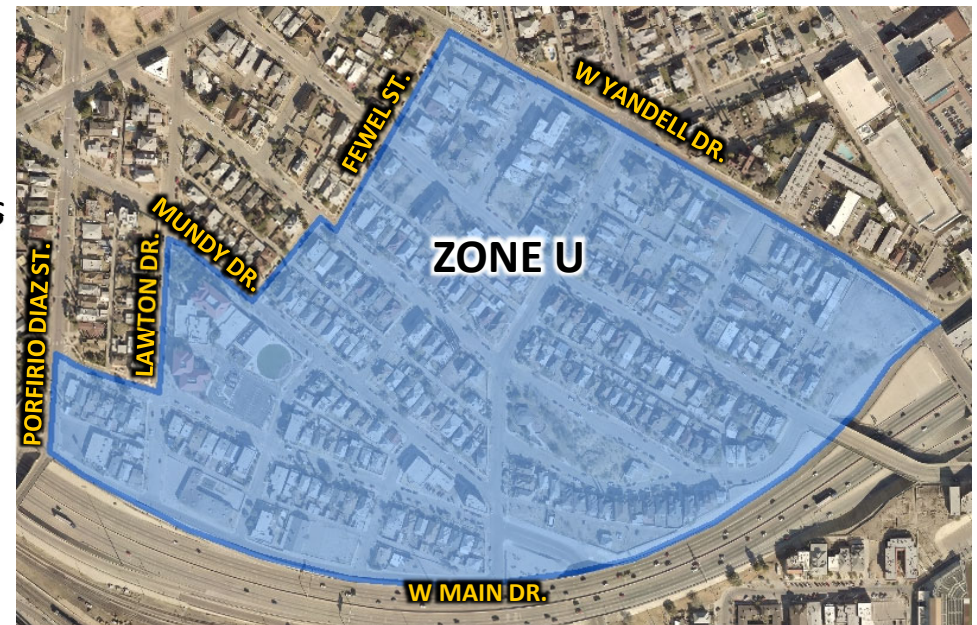

History

April 15, 2014

Ordinance 018163 added Zone U: No parking, 9:00 a.m. to 10:00 p.m., everyday – Restrictions on Parking in Residential Districts was **passed** and **approved** by City Council.

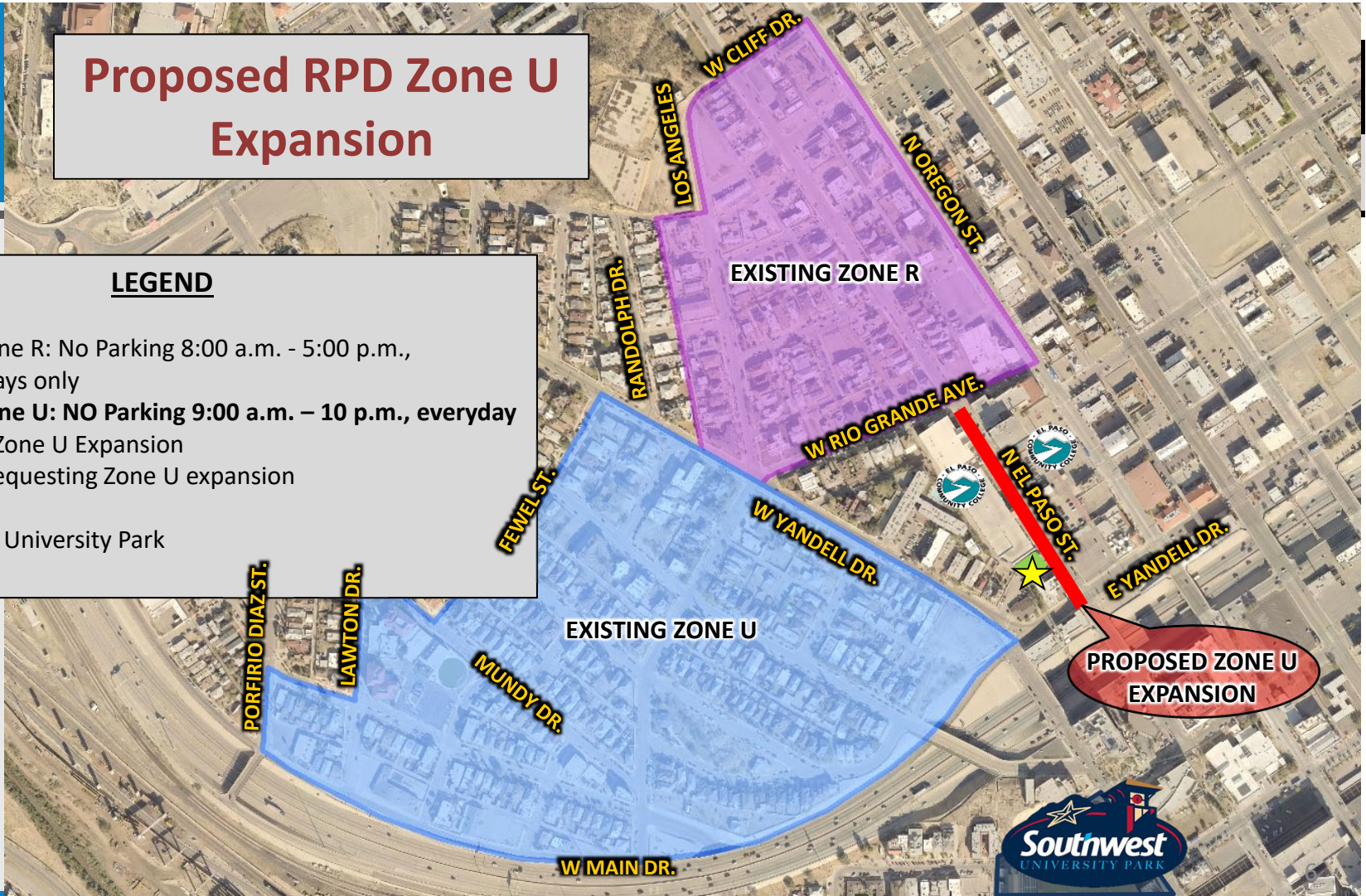




Proposed RPD Zone U Expansion
