SUBJECT:

Via Ordinance, amend Title 12, Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing–Tow-away zone) of the El Paso City Code to add parking restrictions on Glenwood Street, from El Paso Drive to Alameda Avenue, both sides.

BACKGROUND / DISCUSSION:

During the construction of the Capital Improvement Department's Glenwood St. Street Improvements Project, the Streets and Maintenance Department received a request from residents to change the existing "No Stopping or Standing Sundays Only, Tow-Away" restriction to "No Stopping or Standing, Tow-Away". The limits of the requested restriction are Glenwood Street from El Paso Drive to Alameda Avenue, both sides. Glenwood is a two-way street with an 18' travel way.

March 12, 1985

- Motion made and carried to approve the "No Stopping or Standing Sundays Only Tow-Away" on Glenwood Street, from El Paso Drive to Alameda Drive. **Motion approved.**

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING-TOW-AWAY ZONE) OF THE EL PASO CITY CODE TO ADD PARKING RESTRICTIONS ON GLENWOOD STREET, FROM EL PASO DRIVE TO ALAMEDA AVENUE, BOTH SIDES. THE PENALTY BEING PROVIDED IN CHAPTER 12.84 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or standing-Tow-away zone), Subsection A (when signs are erected in the following locations reading substantially, "No parking or standing, tow-away zone," no person shall park or stand any vehicle on the following parts of streets at any time, including, but not limited to Sundays and holidays) be amended to add the following location:

116. Glenwood Street, from El Paso Drive to Alameda Avenue, both sides.

SECTION 2. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.




