- Increase the coordination and integration of air-ground team operations to include Texas Military Forces (TMF) aviation, United States Customs and Border Patrol (USCBP) Air and Marine, Texas Department of Public Safety (DPS) Aircraft Division, and United States Coast Guard (USCG) aviation support.
- Increase the effectiveness of directed action missions based upon intelligence and analysis to ensure they target the most serious threats and are conducted in high pay off areas.
- Increase the number and quality of analytical intelligence products developed at the Unified Command and state levels.
- Increase intelligence based operations at the Unified Command level through integration of TxMap, sector specific information, and intelligence analysis.

- Participate weekly on the JOIC Unified Command conference calls or meetings as required by the JOIC.

Eligible applicants must agree to submit BIAR reports to the JOIC:

<u>Daily Border Incident Assessment Report (BIAR)</u> - The BIAR is the primary incident and information-reporting tool for the grantee in local border security operations. The grantee shall ensure all BIARs conform to the respective standards outlined by the JOIC and are submitted within 24 hours of the end of shift and/or the timeframes established by the JOIC.

The grantee shall report all activities that are considered Steady State activities, in addition to Enhanced Operation activities, to the JOIC. Steady State activities are defined as normal patrol or investigative duties that do not use grant funds, but directly impact the overall local border security mission (organized crime arrests, terroristic activities, weapons trafficking arrests, kidnappings, human trafficking, human smuggling, home invasions with a border or organized crime nexus, illegal immigration, border-related murders, gang-related murders, vehicle thefts, or drug trafficking). Enhanced (Surge) Operations originate out of the use of local border security funds when the local agency chooses to increase the hours of patrol or investigative bodies.

#### **Eligibility Requirements**

<u>Uniform Crime Reporting</u> - Eligible applicants operating a law enforcement agency must be current on reporting Part I violent crime data to the Texas Department of Public Safety (DPS) for inclusion in the annual Uniform Crime Report (UCR). To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year.

<u>Criminal History Reporting</u> - Entitles receiving funds from HSGD must be located in a county that has an average of 90% or above on both adult and juvenile dispositions entered into the computerized criminal history database maintained by the Texas Department of Public Safety (DPS) as directed in the *Texas Code of Criminal Procedure, Chapter 60*. The disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the computerized criminal history system.

Officers will target criminal activity involving money, weapons, ammunition, automobile crimes, gangs, narcotics, wanted subjects and other activities related to crime. Enhanced operations will include but not limited to patrol, surveillance, gang/fugitive roundups, counter auto theft measures and/or Joint Task Force Operations with other local agencies in the suppression of criminal activities to enhance border security and reduce crime along the border region area. El Paso, Texas is directly across the Mexican border of Cludad (Cd.) Juarez, Chihuahua, Mexico. The ongoing territorial drug war that exists between rival cartels within the large metropolitan area of Ciudad Juarez has decreased since January 2011. As the Mexican cartel turf war is subsiding, Drug Traffic Organization's (DTO's), which are often composed of a combination of the Mexican cartel and Transnational Gangs are organizing themselves again and are gaining strength in numbers, building their criminal enterprises. The current number of homicides show a decrease from the year 2011, but a continuous number of homicides still occur on a daily basis in Ciudad Juarez. Homicide statistics from Cludad Juarez Indicate a steady increase of murders within the last three years (2015: 311 murders; 2016: 546 murders; and 2017: 772 murders). The ongoing violence in Cludad Juarez still poses an immediate threat of a spillover into the City and County of El Paso, a threat that has existed for the past several years. The immediate shift has moved towards an organized attempt to smuggle humans and narcotics into the United States. The shift has been attributed to stolen vehicles, weapons, ammunition, and currency illegally leaving out of the United States into Mexico. Members of the criminal element who are often Fugitives from Justice (FFJ) cross our three land ports located within El Paso, Texas. The El Paso Police Department has received Local Border Security grant funds every year since FY12. The incorporation of mobile License Plate Readers (LPR) into daily LBSP operations will facilitate with the identification, location and apprehension of stolen vehicles and wanted subjects within the City of El Paso. Operational times and personnel working each assignment are conditional upon availability of staffing. Staffing levels are estimates and cannot be guaranteed.

#### **Problem Statement:**

El Paso, Texas is directly across the Mexican border of Cludad (Cd.) Juarez, Chihuahua, Mexico, which has a population of over 1.3 million inhabitants (Source: State of Chihuahua CIES). The El Paso-Ciudad Juarez community is the largest metropolitan area on the border between the United States and Mexico. It is estimated that this metropolitan area, that is comprised of El Paso, Texas and Ciudad Juarez, has a combined population of approximately of 2.2 million inhabitants (Source: U.S. Census Bureau and State of Chihuahua CIES). The ongoing territorial drug war that exists between Mexican rival cartels within the large metropolitan area of Cludad Juarez has decreased since January 2011, As the Mexican cartel turf war is subsiding, Drug Traffic Organization's (DTO's), which are often composed of a combination of the Mexican cartel and Transnational Gangs are organizing themselves again and are gaining strength in numbers, building their criminal enterprises. Although, the current number of homicides show a decrease from the year 2011, there remains a continuous number of homicides that occur on a daily basis in Cludad Juarez. Homicide statistics from Cludad Juarez indicate a steady increase of murders over the last three years. The ongoing violence in Cludad Juarez still poses an immediate threat of a spillover into the City and County of El Paso, a threat that has existed for the past several years. The immediate shift has moved towards an organized attempt to smuggle humans and narcotics into the United States. Furthermore, the shift has attributed to stolen vehicles, weapons, ammunition, and currency illegally leaving out of the United States into Mexico. Members of the criminal element who are often Fugitives from Justice (FFJ) cross our three land ports located within El Paso, Texas. The reorganization of the criminal enterprises allows them, within the environment presented, an opportunity to help or fund international terrorists and criminal organizations. The limited amount of federal and local law enforcement threatens vulnerable points within the City and County of El Paso and along the United States-Mexican border. The incorporation of mobile License Plate Readers (LPR) into dally LBSP operations will facilitate with the identification, location and apprehension of stolen vehicles and wanted subjects within the City of El Paso that are often attributed to Drug Trafficking Organizations. A mobile License Plate Reader can be affixed to an unmarked vehicle and read hundreds of vehicle license plates immediately, checking for any NCIC/TCIC wants, giving officers real time data. Law enforcement partnerships are needed to combat this challenging situation. Local Border Security will provide the means to assist in accomplishing the mission of securing our nation's border.

# **Existing Capability Levels:**

Describe the existing capability levels, including resources that are currently in place to support this project prior to the use of grant funds. Currently the personnel resources available to continue working Local Border Security Program (LBSP) operations are derived from funding that has been allotted under the FY18 LBSP Grant. The assignment of police personnel is on an overtime basis and the duties are in addition to the officer's regular scheduled work hours. Operational times and personnel working each assignment are conditional upon availability of staffing and grant funding. Joint operations are normally worked in conjunction with Customs and Border Protection (CBP) at the Three (3) land ports that are located within City of El Paso. The El Paso Police Department currently has eight (8) LPR trailers that were purchased with a Border

Security Grant in FY2008. However, the hardware/software on the LPR trailers are outdated and rendered the LPR trailers obsolete. It would require a complete retrofit of each individual LPR trailer at a cost of approximately \$33,000.00 dollars per trailer. It will cost less money to purchase a complete mobile LPR system at a price of \$25,702.00 dollars per unit, as opposed to retrofitting the current eight LPR trailers.

#### Capability Gaps:

The existence of threats, vulnerabilities, and consequences that exist as part of criminal enterprises are a result of a combination of Mexican Cartels and Transnational Tier-1 gangs (Barrio Azteca, Texas Syndicate, and Mexican Mafia) that operate in both El Paso, Texas and Ciudad Juarez, and contribute to an existing capability gap. The El Paso Police Department is understaffed, which causes a dilemma for effectively addressing the ever-evolving issue because of the personnel shortage. Officers of the El Paso Police Department conduct proactive operations on an overtime basis. Furthermore, these added duties are in addition to their current police responsibilities and have had a positive impact in addressing the issues at hand since FY12. Furthermore, the incorporation of mobile License Plate Readers into daily LBSP operation will allow officers to immediately check vehicles in real time; identify stolen vehicles; identify wanted subjects; and act as a force multiplier for the department due to personnel shortages.

#### **Impact Statement:**

The project goal is to maintain operations that specifically target the criminal enterprises of Mexican Cartels and Transnational gangs that are currently in existence and operating along the El Paso, Texas-Cludad Juarez border. The existence of these criminal enterprises pose harm to the local population of Texans living in El Paso, Texas. The continuation of the current Local Border Security Program will contribute to the reduction of the existing capability gap previously identified.
