## SUBJECT:

Discussion and action on a Resolution that the City finds that Tien L. Kuo, has met the requirements of Section 33.011 of the Tax Code for the request of waiver of penalties and interest on the 2017 delinquent taxes for the property located at 1809 Larry Hinson Dr., pursuant to Section 33.011(1)(a) of the Tax Code in the amount of \$411.09 as a result of an act or omission of the appraisal district.

### BACKGROUND / DISCUSSION:

Pursuant to Section 33.011(1)(a) of the Tax Code, the governing body of a taxing unit shall waive penalties and may provide for the waiver of interest on a delinquent tax in an act or omission of an officer, employee, or agent of the taxing unit or appraisal district in which the taxing unit participates caused or resulted in the taxpayer's failure to pay the tax before delinquency and if the tax is paid not later than the 21<sup>st</sup> day after the taxpayer knows and a request for a waiver was made before the 181<sup>st</sup> day after delinquency.

A citizen has requested a waiver of penalties and interest on 2017 delinquent taxes for a property on February 23, 2018, which was made before the 181<sup>st</sup> day after the delinquency date and the Taxpayer paid the taxes owed not later than the 21<sup>st</sup> day after the taxpayer knew of the delinquency and the taxpayer's failure to pay the tax before the delinquency date was a result of an act or omission of the appraisal district.

WHEREAS, pursuant to Section 33.011(a)(1) of the Tax Code, the governing body of a taxing unit shall waive penalties and may provide for the waiver of interest on a delinquent tax in an act or omission of an officer, employee, or agent of the taxing unit or appraisal district in which the taxing unit participates caused or resulted in the taxpayer's failure to pay the tax before delinquency and if the tax is paid not later than the 21st day after the taxpayer knows or should know or should know of the delinquency; and

WHEREAS, pursuant to Section 33.011(d) a request for waiver of penalties and interest pursuant to Section 33.011(a)(1) must be made before the 181<sup>st</sup> day after the delinquency date; and

WHEREAS, pursuant to Section 33.011(d) of the Tax Code, taxpayer, Tien L. Kuo ("Taxpayer") requested a waiver of penalties and interest in the amount of \$411.09, on the 2017 delinquent taxes for a property located at 1809 Larry Hinson Dr., on February 23, 2018, which was made before the 181st day after the delinquency date; and

WHEREAS, the Taxpayer paid the taxes owed on the property on February 27, 2018, which is not later than the 21<sup>st</sup> day after the date the taxpayer knew or should have known of the delinquency; and

WHEREAS, the Taxpayer's failure to pay the tax before the delinquency date was a result of an act or omission of the appraisal district.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

THAT the Taxpayer, Tien L. Kuo, has met the requirements of Section 33.011 of the Tax Code for the request of waiver of penalties and interest and the City waives the penalty and interest amount on the 2017 delinquent taxes for the property located at 1809 Larry Hinson Dr., pursuant to Section 33.011(a)(1) of the Tax Code in the amount of \$411.09.
