1. FY 2019 Budget: Council and Public Input

Mr. Tommy Gonzalez, City Manager, gave a brief introduction of the item.

Mr. Robert Cortinas, Interim Director of Municipal Finance, presented a PowerPoint presentation, (copy on file in City Clerk's Office).

Mr. Gonzalez explained that July 25 is an important date because that's the date property valuations come in and explained that if they come in lower than projected it results in less revenue. Mr. Gonzalez stated valuations in El Paso compared to appraisal rates are very different.

Representative Perez asked if this is an appraisal year.

Mr. Cortinas confirmed it is.

Representative Perez inquired about the deadline to submit budget requests.

Mr. Cortinas stated it is May 6, 2018.

Mr. Gonzalez explained that the deadline allows staff to prepare.

Representative Hernandez-Brown Annello inquired about the proposed \$4 increase for recycling and if there's a plan to have dedicated revenue source for street maintenance.

Mr. Gonzalez replied that he's asked staff to research street maintenance fees and

explained that it helps take care of on demand requests. He stated that eleven other Texas cities have one, it makes a lot of sense and he's working with Legal on it.
