

### Purpose of Procurement Change Order

A change order for time of 365 consecutive calendar days:

The time extension would re-establish the contract time as originally approved and should provide adequate time to resurface programmed streets on the approved list.

Work shall include:

- Site preparation
- Milling and replacement of asphalt street surface
- Repair of broken concrete elements within the street surface
- Installation of ADA compliant accessibility ramps where feasible
- Application of thermoplastic street lane lines and markings where feasible
