WHEREAS, on December 20, 2011, the City and Sylvia Borunda Firth entered into an Employment Agreement wherein Ms. Firth was appointed City Attorney of the City of El Paso, Texas; and

WHEREAS, the parties now desire to amend the Employment Agreement to extend the term of the agreement and to allow for changes to various sections of the agreement, as set forth herein.

NOW THEREFORE, the parties hereto agree as follows:

- 1. That Section 2, <u>Term</u>, is hereby amended to extend the term of the Agreement for an additional three (3) years to December 19, 2019.
- 2. That Section 3, <u>Termination and Severance Pay</u>, Paragraph A., is hereby amended to remove reference to the Civil Service Rules as relates to the payout of accrued vacation and sick leave owed to Attorney at the time of departure from the City.
- 3. That Section 4, <u>Salary</u>, paragraph A.4, is hereby amended to increase the vehicle allowance to \$500 per month, effective April 1, 2016.
- 4. All other terms and conditions contained in the City Attorney Employment Agreement dated December 20, 2011 not expressly modified herein shall remain in full force and effect.
