WHEREAS, the 2014 Public Art Plan (the "Plan") was approved by City Council on January 7, 2014; and

**WHEREAS**, the City Council now desires to amend the Plan to reflect the current budget for the acquisition or commissioning of art for those projects whose art budgets have increased as a result of an increase to the underlying project budgets; and

**WHEREAS**, the City Council determines that the amended Plan is reasonable and appropriately adopted and that said amended Plan serves the public purpose of enhancing the quality of life of the citizens of El Paso through the development of fine arts and cultural properties and by encouraging the integration of art in the architecture of municipal structures.

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

- 1. That the amended 2014 Public Art Plan for the City of El Paso, Texas ("the Amended Plan"), attached hereto, be and is hereby officially adopted.
- 2. That the Amended Plan includes new projects to be initiated in the 2014 fiscal year, and describes the planned location, proposed budget, timetable and artist selection process for each project, and contains updated budget amounts for public art projects in progress.
- 3. That adoption of the Amended Plan is fully funded through 2010, 2011, and 2012 Certificates of Obligation and the 2012 Quality of Life Bonds.
- 4. That the City Manager or a designee is authorized to enter into contracts to carry out the Amended Plan as described in Amended Exhibit "A" and to revise project budgets to reflect modifications to project budgets subject to the Public Art Program.
