Animal Services of El Paso would like to partner with the Petco Foundation in offering an innovative means of saving lives. We would like to open an adoption center within the El Paso Zoo. This center will be the first-of-its-kind in the entire nation. The "Cat Cafe" would have multiple benefits. First, it would provide our organization with its first satellite adoption center not to include our mobile adoption van and those within two Petco locations. Over 315,000 people visited the zoo last year. This translates to the number of people whom would potentially visit the location and drives awareness of our mission, and messages such as the importance of spay/neuter and microchips. Zoo visitors will have the opportunity to interact, hands-on, directly with the felines in a lounge-like atmosphere. This will further enhance the visitor experience at the zoo while conveying the messages that align with the vision of Animal Services. There is existing building with a glass front that measures 50ft x 30ft, has a 12ft x 15ft alcove with two glass sides, office space, a storage area and restrooms. We would like to retrofit this building with a secondary containment feature for the purpose of not letting the cats that are roaming free in the lounge to get out. Furthermore, cat friendly furniture (sofas, patio sets, desks, recliners and lounge chairs), Shore-line Kat Play and Sleep banks, enrichment devices such as scratching posts, perches/trees, condos and tunnels will be purchased so that visitors can experience the cats in their most natural states. Cat supplies such as litter, food and toys will also need to be obtained. The satellite adoption center will be managed by existing Animal Services staff and hopes to have 50 cats per month adopted.





This responds to your request for information about your federal tax status. Our records do not specify your federal tax status. However, the following general information about the tax treatment of state and local governments and affiliated organizations may be of interest to you.

#### GOVERNMENTAL UNITS

Governmental units, such as States and their political subdivisions, are not generally subject to federal income tax. Political subdivisions of a State are entities with one or more of the sovereign powers of the State such as the power to tax. Typically they include counties or municipalities and their agencies or departments. Charitable contributions to governmental units are tax-deductible under section 170(c)(1) of the Internal Revenue Code if made for a public purpose.

ENTITIES MEETING THE REQUIREMENTS OF SECTION 115(1)
An entity that is not a governmental unit but that performs an essential government function may not be subject to federal income tax, pursuant to Code section 115(1). The income of such entities is excluded from the definition of gross income as long as the income (1) is derived from a public utility or the exercise of an essential government function, and (2) accrues to a State, a political subdivision of a State, or the District of Columbia. Contributions made to entities whose income is excluded income under section 115 may not be tax deductible to contributors.

#### TAX-EXEMPT CHARITABLE ORGANIZATIONS

An organization affiliated with a State, county, or municipal government may qualify for exemption from federal income tax under section 501(c)(3) of the Code, if (1) it is not an integral part of the government, and (2) it does not have governmental powers inconsistent with exemption (such as the power to tax or to exercise enforcement or regulatory powers). Note that entities may meet the requirements of both sections 501(c)(3) and 115 under certain circumstances. See Revenue Procedure 2003-12, 2003-1 C.B. 316.

Most entities must file a Form 1023, Application for Recognition of Exemption Under Section 501(c))(3) of the Internal Revenue Code, to request a determination that the organization is exempt from federal income tax under 501(c)(3) of the Code and that charitable contributions are tax deductible to contributors under section 170(c)(2). In addition, private foundations and other persons sometimes want assurance that their grants or contributions are made to a governmental unit or a public charity. Generally, grantors and contributors may rely on the status of governmental units based on State or local law. 
