

# Training

- sUAS training is provided through UTEP by Dr. Michael McGee. Dr. McGee is considered an expert in both manned and unmanned aviation and is well versed on FAA regulations.
- All pilots operating a UAS must have a current remote pilot certificate under 14 CFR Part 107 of the FAA Rules and Regulations.
- Application fee of \$150.00 for the license.
- Monthly training

All drones have extra batteries and chargers for extended usage.

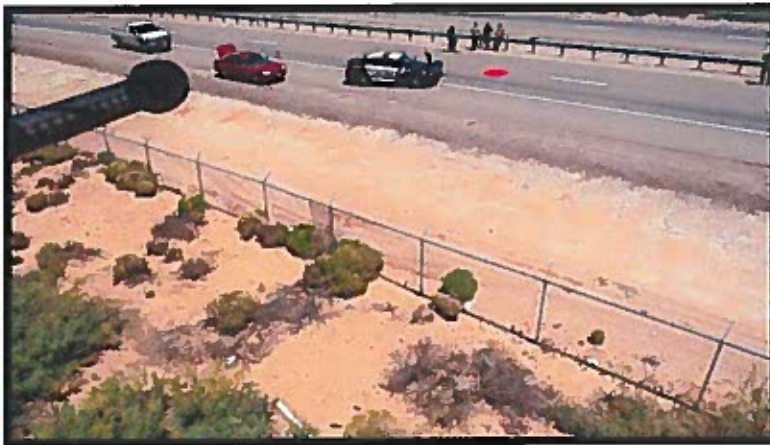

# Benefits

1. Efficient  
Hurricane Harvey, drones were used to quickly locate trapped people and deploy resources
2. Force Multiplier  
Can cover a lot of space in a little time; assist in mapping large crime or accident scenes.
3. Enhance officer and public safety  
Assist officers in recognizing dangers and prevent injury; useful in hazardous material investigations
4. Allow access to difficult to reach locations  
Roof tops, remote areas

# Public Safety Threat

Government Code: Chapter 423. Use of Unmanned Aircraft

- Class C Misdemeanor if person uses an unmanned aircraft to *capture an image of an individual or privately owned real property* in this state with the intent to conduct surveillance on the individual or property captured in the image.
- Class B Misdemeanor if a person *operates an unmanned aircraft over a correctional facility, detention facility, or critical infrastructure facility* and the unmanned aircraft is not higher than 400 feet above ground level; allows an unmanned aircraft to come within a distance of a correctional facility, detention facility, or critical infrastructure facility that is close enough to interfere with the operations of or cause a disturbance to the facility.
- Class B Misdemeanor if a person *operates an unmanned aircraft over a sports venue* (30,000 or more) and the unmanned aircraft is not higher than 400 feet above ground level.

- Currently coordinating with other local, state and federal law enforcement agencies as well as UTEP to develop strategies to address these issues.
