Action Item No. 6, Consider and take possible action to extend the school zones on Yarbrough for Bel Air HS at a cost of \$96,518 to be shared with the City paying 40%. Trustee Federico made a motion to approve extending the school zones on Yarbrough for Bel Air HS at a total cost of \$96,518 to be shared with the City paying 40%, and the District paying 60%, pending City approval. A second was provided by Trustee Haggerty, and vote of approval was unanimous by the following trustees: Trustee Ramirez, Trustee Haggerty, Trustee Federico, Trustee Reyes and Trustee Kahoe. Trustees Lewis and McLean were not on the dais at the time of the vote.
