STRATEGIC GOAL NO. 2: Set the Standard for a Safe and Secure City

SUBJECT:

The award of Solicitation No. 2018-792R 12-Lead Field Cardiac Monitors/Defibrillators to ZOLL Medical Corporation, for a one time purchase estimated award of \$1,016,765.00. The Zoll cardiac monitor is a portable cardiac monitor with the following capabilities: continuous cardiac monitoring, acquiring interpreting and transmitting 12-lead EKGs, defibrillator/external pacemaker, SpO2, SpCO, CO2, temperature and non-invasive blood pressure monitoring in adult/pediatric.

BACKGROUND / DISCUSSION:

Solicitation #2018-792R, for the acquisition of up to 42 ZOLL Cardiac Monitors. The new monitors will replace existing devices that have reached their life expectancy. The Fire Department received a matching grant to purchase the monitors.

SELECTION SUMMARY:

Solicitation was advertised on 11/21/2017 and 11/28/2017. The solicitation was posted on City website on 11/21/2017. The email (Purmail) notification was sent out on 11/23/2017. There was a total of twenty-four (24) views. Total of four (4) proposals were solicited; none local vendors. Two (2) proposals were received; none were local. An Inadequate Competition Survey was conducted.
