SUBJECT:
Award Solicitation 2015-657 Grounds Maintenance for El Paso City Parks-Mowing to Tree D's Landscaping & Ground Maintenance and WCD Enterprises, LLC as recommended by the Evaluation Committee and the Department of Parks & Recreation. The period of performance is from May 5, 2015 through May 4, 2017.

BACKGROUND / DISCUSSION:
The Parks and Recreation Department is recommending the award of Solicitation #2015-657 Grounds Maintenance for El Paso City Parks-Mowing to Tree D's Landscaping & Ground Maintenance \$46,440.96 (2 years) and WCD Enterprises, LLC \$369,159.68 (2 years) which was offered the Best Value to the City. If approved, this award will allow for mowing services to 66 parks/295 acres throughout the City. This contract will replace the previous contract that was terminated due to the fact contract awardee filed for bankruptcy and could no longer provide the services.

The term of this contract shall be for twenty four (24) months.

SELECTION SUMMARY:
Solicitation was advertised on 02/03/2015 and 02/10/2015. The postcards were mailed out on 02/03/2015. The solicitation was posted on City website on 02/03/2015. The email (Purmail) notification was sent out on 02/03/2015. A total of thirty five (35) bidders, including thirty three (33) local vendors were solicited. A total of six (6) bids were received, five (5) being local vendors.




