AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041 (SCHEDULE IV A-PARKING PROHIBITED DURING CERTAIN HOURS-SCHOOL DAYS ONLY) OF THE EL PASO CITY CODE, BY ADDING MAYA LIZABETH PLACE, BREEAN ISABELL PLACE, AND TIERRA INCA DRIVE BETWEEN TIERRA ESTE DRIVE AND PABLO SANCHEZ PLACE, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

Residents submitted a petition for restricting parking on Tierra Inca, Breean Isabell, and Maya Lizabeth and based upon signatures and contacting the residents, we've deemed there is sufficient support of this ordinance. Department of Transportation recommends restricting parking during school hours.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041 (SCHEDULE IVA- PARKING PROHIBITED DURING CERTAIN HOURS—SCHOOL DAYS ONLY) OF THE EL PASO CITY CODE, BY ADDING MAYA LIZABETH PLACE, BREEAN ISABELL PLACE, AND TIERRA INCA DRIVE BETWEEN TIERRA ESTE DRIVE AND PABLO SANCHEZ PLACE, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041 (Schedule IVA- Parking prohibited during certain hours—school days only) of the El Paso City Code shall be and hereby is amended to add the following streets to the streets presently listed in Section A:

22. Maya Lizabeth Place.

23. Breean Isabell Place.

24. Tierra Inca Drive between Tierra Este Drive and Pablo Sanchez Place.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041 (Schedule IVA- Parking prohibited during certain hours—school days only) of the El Paso City Code shall remain in full force and effect.




