1. Presentation and discussion on The Power of our Strategic Plan: El Paso Transformational Results with reports by the following departments:

Purchasing and Strategic Sourcing

Mr. Bruce Collins, Purchasing and Strategic Sourcing Director, Ms. Claudia Garcia, Purchasing and Strategic Sourcing Assistant Director, and Ms. Aimee Olivas, Purchasing and Strategic Sourcing Socioeconomic Compliance Officer, presented a PowerPoint presentation (copy on file in the City Clerk's Office).

This presentation included information regarding the support provided by the department specifically related to the COVID-19 pandemic along with an overview of the department's core functions and responsibilities, information on purchasing and supply chain management, contract administration, wage theft, socioeconomic programs. Council members were also briefed on the outreached performed by the department in the way of workshops and expos and the recent awards and recognitions received.

• Office of the Comptroller

Mr. Robert Cortinas, Chief Financial Officer, presented a PowerPoint presentation (copy on file in the City Clerk's Office).

Mr. Cortinas provided an overview and improvements implemented on the level of transactions handled by the department including cash portfolio handled, vendor payments, P-card transactions, payroll processing, including active employees and

retirees, accounting and financing of capital assets, debt service payments, in addition to overseeing City's revenues and grants.

Mr. Cortinas' presentation also included information on the different ways the Office of the Comptroller is focusing on their workforce by means of trainings and certifications as well as the cross-training of employees in order to ensure continuity of operations.

Office of Management and Budget

Ms. Nicole Cote, Office of Management and Budget Director, presented a PowerPoint presentation (copy on file in the City Clerk's Office).

Ms. Cote briefed Council members on the department's activities related to COVID-19 and how they have affected the fiscal year 2020 budget in revenue and expenditures.

Ms. Cote also presented on the cycles of learning the department has gone through on the last five years, the integrated and streamlined budget process, the City's cross functional teams developed to address issues and inefficiencies, the increased efforts on community outreach and engagement including the success of the Chime In! Survey and focus groups. The presentation also included a section highlighting the department's awards and recognitions.

Ms. Karla Nieman, City Attorney, presented a PowerPoint presentation (copy on file in the City Clerk's Office).

Ms. Nieman's presentation included a section on the departmental improvements to processes and workforce focus, such as the collaboration with the Performance Office, the implementation of internal and external surveys, focus groups, Lean Six Sigma projects and the training for lawyers and support staff, promotions within the department and a flexible schedule.

WHEREAS, pursuant to Section 7.3 of the City of El Paso municipal code, the City Council approved the FY 2020 City budget by resolution ("Budget Resolution"); and

WHEREAS, on the March 13, 2020 the City of El Paso the Governor of the State of Texas declared a state of disaster, the President of the United States of America declared a national emergency, and the Mayor of the City of El Paso declared a local disaster in relation to COVID-19; and

WHEREAS, on March 17, 2020, the City Council of El Paso adopted and Emergency Ordinance extending the City's state of disaster and instituting emergency measures due to a public health emergency; and

WHEREAS, on March 24, 2020, the Mayor of the City of El Paso issued a Local Emergency Directive for all individuals residing in the City of El Paso to stay at home or at their place of residence; and

WHEREAS, the City desires to amend the FY2020 Budget Resolution to allow the City to make necessary budget changes to respond to the financial impacts of the COVID-19 emergency;

WHEREAS, paragraph 20 of the FY2020 Budget Resolution authorizes the Employees' annual pay increase; and

WHEREAS, the City desires to amend paragraph 20 to implement adjustments to Employee's pay increases and payment of certain management positions which are necessary to respond to the financial impact of the COVID-19 emergency; and

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

- 1. That paragraph 20 of the FY2020 of the Budget Resolution is amended as follows:
- 20. That the amounts of the annual non-uniformed employee pay increases for FY 2020 which will be in effect from March 1, 2020 through May 23, 2020 and are set as follows: Employee's annual increase shall be in that amount that will place the employee in the rate within their pay grade that most closely approximates a one percent (1.0%) increase, unless a higher percentage increase results from the implementation of a compensation study. Provided however, that the City Manager may increase this amount by an amount not to exceed an additional one percent (1.0%) for any or all of

the City's two major service classifications and the unclassified services based on the availability of funds and other management factors as determined by the City Manager. Provided however, nothing in this section authorizes the payment of a base salary that exceeds the maximum of an employee's salary range.

An across the board reduction of wages will be in effect on May 24, 2020 through August 15, 2020 for the following appointed positions and job pay grades as defined in Ordinance 8064 and associated job specifications:

- (A) City Manager and City Attorney- 5% pay decrease.
- (B) Assistant City Attorneys 2% pay decrease.
- (C) Appointed Municipal Court Judges 2 % pay decrease.
- (D) Pay Grades EX 1 and EX 2- 5% pay decrease.
- (E) Pay Grades EX 3, EX 4 and EX 5- 2% pay decrease.
- (F) Pay Grades GS and PM 1 % pay decrease.

Effective August 16, 2020, the wages for all positions identified above will revert to the wages that were in effect prior to May 24, 2020.

RESOLUTION

WHEREAS, on March 13, 2020, the Governor of the State of Texas declared a state of disaster, the President of the United States of America declared a national emergency, and the Mayor of the City of El Paso declared a local state of disaster due to the COVID-19 pandemic; and

WHEREAS, in order to protect employee health and safety during the COVID-19 outbreak, the City implemented a Telecommute Policy and provided additional administrative leave for employees whose work was impacted by the health pandemic; and

WHEREAS, despite the City's and Federal (Families First Coronavirus Response Act & Coronavirus Aid, Relief, and Economic Security Act) efforts to support employees through the provision of leave, many employees who are unable to perform their work from home have exhausted available leave; and

WHEREAS, the closure or indefinite delay of several City facilities, services, projects and programs has drastically impacted the City's operating economy and budget; and

WHEREAS, COVID-19 is expected to have a widespread and long lasting financial impact within the local community; and

WHEREAS, as a result of COVID-19 financial and operational impacts, the City's Budgetary Revenue now faces a \$33 million impact in the current Fiscal Year; and

WHEREAS, this financial and operational impact is anticipated to continue for an unknown period of time;

WHEREAS, El Paso City Charter Section 5.2-1 allows the City Manager to take all personnel actions regarding employees except as provided by law or in the Charter; and

WHEREAS, El Paso City Charter Section 6.9-2, authorizes and directs the Human Resources Director, subject to the approval of City Council, to establish systems for reducing the impact on the Civil Service of staff reductions and layoffs caused by operating economies; and

WHEREAS, a furlough is mandatory unpaid time off from work for a certain period of time that is limited in duration and implemented by an employer as a cost-saving measure; and

WHEREAS, a furlough is a less severe alternative to a lay-off or staff reductions as it allows an employee to remain employed as opposed to requiring a separation in employment; and

WHEREAS, a furlough, once declared, would immediately enable employees to become eligible for state unemployment benefits; and

WHEREAS, a furlough when declared by the City Manager would allow the City the ability to address significant budgetary shortfalls during an economic downturn; and

WHEREAS, in order to minimize the impact on the Civil Service of staff reductions and layoffs, the Human Resources Director desires to seek the City Council's approval for the establishment of a furlough system; and

WHEREAS, the City Council desires to approve the establishment of the proposed furlough system and to adopt the Human Resources Director's policy effectuating the same.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF EL PASO, TEXAS:

That the City Council approves of the Human Resources Director's establishment of a furlough system and adopts the Human Resources Director's furlough policy attached hereto as Exhibit A.
