### **SUBJECT:**

The Municipal Clerk and Courts Department is requesting this contract to obtain mailing services for the Municipal Court. Approximately 38,000 to 61,000 pieces are mailed out on a monthly basis. Documents include court hearing notices to defendants, attorneys, witnesses, bail bond companies, warrant notices, juvenile notices, parking courtesy notices, bond forfeiture conviction postcards and other correspondence.

Solicitation was advertised on April 19, 2016 and April 26, 2016. The solicitation was posted on City website on April 19, 2016. The email (Purmail) notification was sent out on April 19, 2016. A total of (6) Bidders were solicited with (6) of those being local. (1) Bid was received; (1) local vendor.
