### **SUBJECT:**

### RESOLUTION

WHEREAS, taxpayer, Chicken Ranch Road, J.V. ("Taxpayer") has applied for a refund with the tax assessor for their 2012 property taxes that were overpaid on January 31, 2013 in the amount of \$65.35 for all taxing entities; and

WHEREAS, City Council may extend the deadline for the Taxpayer's application for the overpayment of the 2012 taxes for a period not to exceed two years on a showing of good cause by the taxpayer; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:
