THE PENALTY IS AS PROVIDED FOR IN CHAPTER 20.24 OF THE EL PASO CITY CODE

WHEREAS, on October 12, 1999, City Council rezoned the property described as the South 1/3 of Lot 15 and all of Lots 16-20, Block 67, Harts Survey No. 9 of the Satterwaite Addition, City of El Paso, El Paso County, Texas, from **C-1 (Commercial) to S-D/c (Special-Development/condition)** and as part of the rezoning imposed a condition that prior to issuance of building permits or a certificate of occupancy a detailed site development plan be submitted for approval by the City Plan Commission and City Council prior to issuance of a building permit or certificate of occupancy; and,

WHEREAS, the property owner, **Revery Investments, LLC** (the "Owner") is ready to proceed with development and has submitted a detailed site development plan for review; and,

WHEREAS, the detailed site development plan is subject to the development standards in the **S-D/c (Special-Development/condition)** District regulations and subject to the approved Detailed Site Development Plan signed by the Applicant, the City Manager and the Executive Secretary to the City Plan Commission; and,

WHEREAS, a report was made by the City Staff to the City Plan Commission and a public hearing was held regarding such application; and,

WHEREAS, the City Plan Commission has approved and herein recommends Council approval of the subject detailed site development plan; and

WHEREAS, the City Council finds that the detailed site development plan meets all applicable requirements of the El Paso City Code;

WHEREAS, Phase I of the Project shall consist of the design and construction, at no cost to the City, of a three-way (T-intersection) traffic signal that will control the traffic flow for State Highway 20 (Mesa Street) for northbound and southbound approaches and Montecillo Blvd. for the eastbound approach; and

WHEREAS, Phase II of the Project shall consist of the design and construction, at no cost to the City, of an additional traffic signal at the same intersection of the three-way traffic signal by adding one (1) additional traffic signal, to create a 4-way traffic signal that will control all traffic flow approaches including the westbound traffic flow approach from the Montecillo Unit Five Subdivision (East of Mesa Street); and

WHEREAS, Developer's design and construction of the Project will ensure that traffic flow moves as smoothly and safely as possible and that pedestrians are protected when they cross the roads, thereby increasing traffic safety at the main entrances of Montecillo Unit Three Subdivision and Montecillo Unit Five Subdivision and will be an economic benefit to local tax payers, and therefore, this Agreement is in the best interest of the citizens of the El Paso;

WHEREAS, Developer and City desire to enter into an agreement whereby each will bear certain responsibilities regarding the installation, maintenance and upkeep of the Project;
