SUBJECT:

Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV – Speed Limits) to amend by deleting Country Club Road from Doniphan Drive to the west city limits from Subsection (G) and adding the same location to Subsection (F). The penalty being provided in Chapter 1.08 (General Penalty) of the El Paso City Code.

BACKGROUND / DISCUSSION:

This ordinance amendment corrects the Municipal Code to reflect existing speed limit signs on Country Club road. The posted speed limit on Country Club Road from Doniphan Drive to the west city limits was changed upon completion of the Country Club Road reconstruction project; when this happened the Municipal Code was not updated to reflect changes made in posted speed limit signs.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV-SPEED LIMITS) TO AMEND BY DELETING SUBSECTION (G) AND ADDING SUBSECTION (F). THE PENALTY BEING PROVIDED IN CHAPTER 1.08 (GENERAL PENALTY) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV- Speed Limits), Paragraph G (Forty Miles Per Hour), subparagraph (1) which reads “Country Club Road from Doniphan Drive to west city limits”, be deleted in its entirety.

Section 2. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV- Speed Limits), Paragraph F (Thirty-five Miles Per Hour) is hereby amended to add the following:

101. Country Club Road from Doniphan Drive to the west city limits.

Section 3. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.

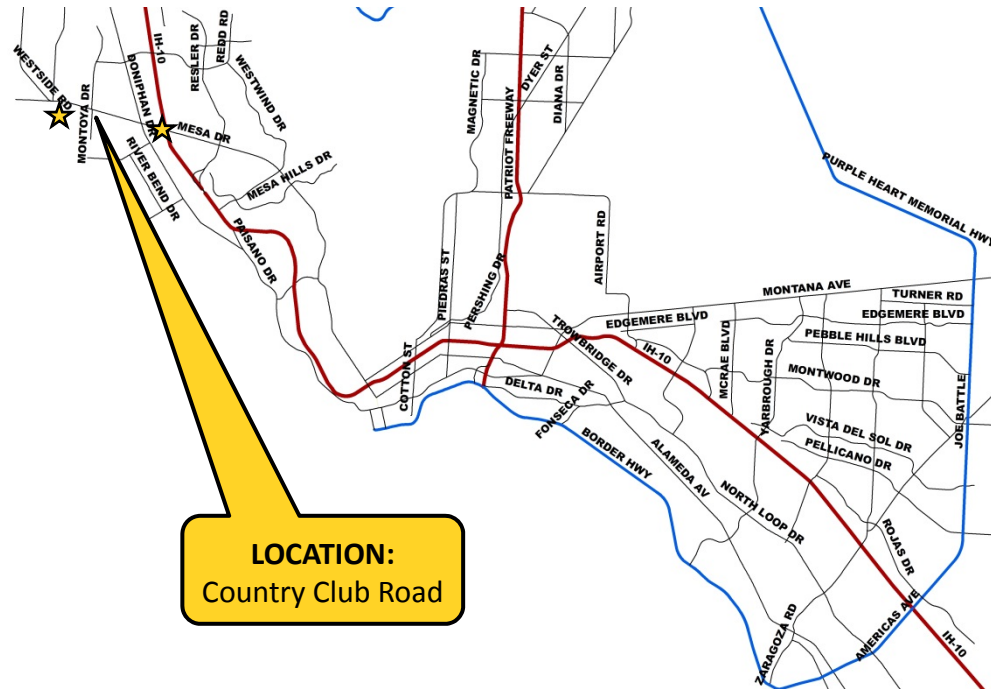
