I. <u>Discussion and action on the Hub of Human Innovation Inc. grant funding request</u>
for a Hub and Clean Energy Incubator program, a Proof of Concept program, a
Certification Center and Odyssey program as detailed in the Hub of Innovation's
Proposal to the City of El Paso for activities over a four year periods in the amount
of \$2,305,000.00.

#### Summary:

Presentation given by Gary Williams from UTEP on possible City funding for entrepreneurship incubation activities. Representative Byrd proposed that an annual review of activities be stipulated in possible contract.

#### Action Taken:

The LRC unanimously approved that item be brought forward to City Council.

II. <u>Discussion and action on regulating the placement of signs on City of El Paso right of Way.</u>

#### Summary:

Overview by Mathew McElroy, Planning and Economic Development Department, on possible enforcement of permit display requirement on signs on right of way streets. Representative Acosta detailed current complaints from community on signage on Gateway East and Viscount.

## Action Taken:

The LRC voted 4-1 to only permit the posting of signs in the right-of-way with a permit.

III. Discussion and action on terms, conditions, and requirements for City approval of the extension of the City's waiver of PILOT (payment in lieu of taxes) fees from the Housing Authority of the City of El Paso (HACEP) pursuant to the parties'

Cooperation Agreement as amended.
