The penalty being as provided in Section 12.84.010 (A) and 12.84.010 (B) of the El Paso City Code.

Streets and Maintenance received a request from residents to restrict parking in the neighborhood adjacent to two schools (SSG Manuel R Puentes Middle School and James P Butler Elementary School), experiencing overwhelming parking and congestion burdens during school entry and release times.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.200 (SCHEDULE XVII-RESTRICTIONS ON PARKING IN RESIDENTIAL DISTRICTS), SUBSECTION (K) (NO PARKING 7:00 A.M. TO 4:00 P.M., SCHOOL DAYS ONLY) TO ADD LONE POINT COURT; NAVAJO POINT DRIVE; APACHE POINT DRIVE; HAWK POINT PLACE; AND FURY POINT PLACE. THE PENALTY BEING PROVIDED IN SECTIONS 12.84.010 (A) AND 12.84.010 (B) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVII-Restrictions on parking in residential), Subsection Zone (K) (No parking 7:00 a.m. to 4:00 p.m., school days only) is hereby amended to add the following:

Lone Point Court;
Navajo Point Drive;
Apache Point Drive;
Hawk Point Place;
Fury Point Place

Section 2. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
