## **BACKGROUND / DISCUSSION:**

Streets and Maintenance received a request from residents to restrict parking along Coloma Circle, near Liberty Street, due to the narrow roadway width when vehicles are parked along the curb. The parking restriction limits are on the north side of Coloma Circle, from Liberty Street to a point 360' east thereof.

# AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING-TOW AWAY ZONE), SUBSECTION A TO AMEND TO ADD A LOCATION. THE PENALTY BEING PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**SECTION 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing-Tow-away zone), Subsection A is hereby amended to add the following:

115. North side of Coloma Circle, from Liberty Street to a point 360 feet east thereof.

**SECTION 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
