Amend Title 12 (Vehicles and Traffic), Chapter 12.20 (Traffic Control Devices) Section 12.88.010 (Schedule I – One-way Streets), Subsection 20 (Yandell Drive), to amend to read, Westbound from Birch Street to Santa Fe Street. The penalty being as provided in Section 12.84.010 (B) of the El Paso City Code.

**BACKGROUND / DISCUSSION:**

Streets and Maintenance received a request from Sun Metro to convert one block of Yandell Drive, from N Piedras Street to Birch Street, from one-way to two-way. This conversion will allow buses to efficiently service the northbound and southbound bus stops on Birch Street.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.010 (SCHEDULE I-ONE-WAY STREETS), SUBSECTION 20 (YANDELL DRIVE) TO AMEND TO READ WEST FROM BIRCH STREET TO SANTA FE STREET. THE PENALTY BEING PROVIDED IN SECTION 12.84.010 (B) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**SECTION 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.010 (Schedule I- One-Way Streets), Subsection 20 (Yandell Drive) is hereby amended in its entirety to read as follows:

20. Yandell Drive. West from Birch Street to Santa Fe Street.

**SECTION 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
