

ORDINANCE NO. _____

AN ORDINANCE ORDERING A BOND ELECTION TO BE HELD IN THE CITY OF EL PASO, TEXAS, ON NOVEMBER 5, 2019, MAKING PROVISIONS FOR THE CONDUCT OF THE ELECTION AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTION.

WHEREAS, the City Council of the City of El Paso, Texas (the “City”) hereby finds that an election should be held to determine whether such governing body shall be authorized to issue bonds of the City in the amounts and for the purposes hereinafter identified;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1: An election shall be held on November 5, 2019, in the City, which date is not less than seventy-eight (78) nor more than ninety (90) days from the date of the adoption hereof and is a uniform election date pursuant to Texas Election Code, Section 41.001, for the purpose of submitting the following measures:

CITY OF EL PASO, TEXAS PROPOSITION A – PUBLIC SAFETY

“SHALL the City Council of the City of El Paso, Texas, be authorized, in accordance with applicable law, to issue bonds of the City, in one or more series or issues and in the aggregate principal amount of \$592,487,832, with such series or bonds, respectively, to mature serially or otherwise within a period not to exceed forty years from their date and to be sold at such prices and bear interest at such rates (whether fixed, floating, variable, or otherwise, but in no case at a rate that exceeds the maximum rate per annum authorized by applicable law at the time of any such issuance), as shall all be determined within the discretion of the City Council, for permanent public improvements and public purposes, to wit: acquiring, planning, designing, constructing, renovating, improving, expanding and equipping public safety facilities, including acquiring land and rights-of-way necessary thereto or incidental therewith, acquiring motor vehicles and equipment for Police and Fire Departments, and acquiring and installing public art related to and being a part of some or all of the foregoing; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the interest on the bonds and provide a sinking fund to pay the principal of the bonds at maturity and to pay the costs of any credit agreements executed in connection with the bonds?”

CITY OF EL PASO, TEXAS PROPOSITION B - STREETS

“SHALL the City Council of the City of El Paso, Texas, be authorized, in accordance with applicable law, to issue bonds of the City, in one or more series or issues and in the aggregate principal amount of \$268,131,612, with such series or bonds, respectively, to mature serially or otherwise within a period not to exceed forty years from their date and to be sold at such prices and bear interest at

such rates (whether fixed, floating, variable, or otherwise, but in no case at a rate that exceeds the maximum rate per annum authorized by applicable law at the time of any such issuance), as shall all be determined within the discretion of the City Council, for permanent public improvements and public purposes, to wit: planning, designing, constructing, renovating, improving, resurfacing, restructuring and extending streets, thoroughfares alleys, sidewalks, bridges, intersections, screening walls and other public ways, including participation in joint projects with federal, state and local public entities and agencies, computerized signalization and monitoring equipment and other traffic controls, grade separations, street lighting, streetscapes, landscape, signage, noise abatements, necessary and related storm drainage facilities and improvements, and the acquisition of any land and rights-of-way necessary thereto or incidental therewith; and acquiring and installing public art related to and being a part of some or all of the foregoing; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the interest on the bonds and provide a sinking fund to pay the principal of the bonds at maturity and to pay the costs of any credit agreements executed in connection with the bonds?”

CITY OF EL PASO, TEXAS PROPOSITION C – PUBLIC HEALTH

“SHALL the City Council of the City of El Paso, Texas, be authorized, in accordance with applicable law, to issue bonds of the City, in one or more series or issues and in the aggregate principal amount of \$71,418,095, with such series or bonds, respectively, to mature serially or otherwise within a period not to exceed forty years from their date and to be sold at such prices and bear interest at such rates (whether fixed, floating, variable, or otherwise, but in no case at a rate that exceeds the maximum rate per annum authorized by applicable law at the time of any such issuance), as shall all be determined within the discretion of the City Council, for permanent public improvements and public purposes, to wit: acquiring, planning, designing, constructing, renovating, improving, expanding and equipping City public health facilities, including acquiring land and rights-of-way necessary thereto or incidental therewith, and acquiring and installing public art related to and being a part of some or all of the foregoing; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the interest on the bonds and provide a sinking fund to pay the principal of the bonds at maturity and to pay the costs of any credit agreements executed in connection with the bonds?”

CITY OF EL PASO, TEXAS PROPOSITION D – ANIMAL SERVICES

“SHALL the City Council of the City of El Paso, Texas, be authorized, in accordance with applicable law, to issue bonds of the City, in one or more series or issues and in the aggregate principal amount of \$10,969,088, with such series or bonds, respectively, to mature serially or otherwise within a period not to exceed forty years from their date and to be sold at such prices and bear interest at such rates (whether fixed, floating, variable, or otherwise, but in no case at a rate that exceeds the maximum rate per annum authorized by applicable law at the

time of any such issuance), as shall all be determined within the discretion of the City Council, for permanent public improvements and public purposes, to wit: acquiring, planning, designing, constructing, renovating, improving, expanding and equipping City animal services facilities, including acquiring land and rights-of-way necessary thereto or incidental therewith, and acquiring and installing public art related to and being a part of some or all of the foregoing; and whether ad valorem taxes shall be levied upon all taxable property in the City sufficient to pay the interest on the bonds and provide a sinking fund to pay the principal of the bonds at maturity and to pay the costs of any credit agreements executed in connection with the bonds?”

SECTION 2: In accordance with the provisions of a Joint Election Agreement and Contract for Election Services (the “Contract”) to be executed with the El Paso County Elections Administrator, the election shall be conducted by the El Paso County Elections Administrator in accordance with the provisions of the Contract. The City Manager or his designee is hereby authorized to execute the Contract and any other necessary contract(s) and agreements, joint or otherwise, with the El Paso County Elections Administrator, or any other public entity, for the purpose of having El Paso County furnish all or any portion of the election services and equipment needed by the City Clerk to conduct the election. The contract document and election services provided therein shall conform to Chapter 31, Subchapter D, of the Texas Election Code and all other applicable statutes and laws.

The City shall be divided into election precincts for this election and the polling places designated for each election precinct are shown in **Exhibit A**, which is attached hereto and incorporated herein by reference as a part of this Ordinance for all purposes. The election officers and maximum number of clerks for such polling places shall be determined and appointed in accordance with the provisions of the Contract.

On election day, the polls shall be open from 7:00 a.m. to 7:00 p.m.

The main location, dates and times for early voting for this election shall be as shown in **Exhibit B**, which is attached hereto and incorporated herein by reference as a part hereof for all purposes. In addition, mobile voting stations may be authorized and used for early voting at publicly owned buildings in the City as established by the El Paso County Elections Administrator. **Exhibit B** may be modified to include any changes to early voting designated by the El Paso County Elections Administrator and to conform to the Contract and the City Clerk is authorized to make any conforming corrections or revisions to Exhibit B. Additional early voting locations may be designated by the El Paso County Elections Administrator. Lisa Wise, El Paso County Elections Administrator, is hereby appointed early voting clerk and shall appoint and designate deputy clerks for early voting in accordance with the Contract. For purposes of processing ballots cast in early voting, the election officers for the early voting ballot board for this election shall be appointed and designated in accordance with the provisions of the Contract.

The Central Counting Station for the tabulation and counting of ballots for this election shall be located at the El Paso County Elections Department, 500 E. San Antonio, Suite 314, El Paso, Texas 79901, and the Manager, Tabulation Supervisor, [Programmer,] Presiding Judge and

Alternate Presiding Judge at the Central Counting Station shall be appointed and designated in accordance with the provisions of the Contract.

The Manager and Presiding Judge of the Central Counting Station may appoint clerks to serve at such Station, as provided by Section 127.006 of the Election Code.

SECTION 3: A voting system or systems meeting the standards and requirements of the Texas Election Code, as amended, is hereby adopted and approved for early voting by personal appearance and by mail and for election day voting.

Ballots shall be prepared in accordance with Texas Election Code, and permit electors to vote “FOR” or “AGAINST” the aforesaid measures which shall appear on the ballot substantially as follows:

CITY OF EL PASO, TEXAS PROPOSITION A – PUBLIC SAFETY

“THE ISSUANCE OF \$592,487,832 GENERAL OBLIGATION BONDS FOR PUBLIC SAFETY FACILITIES INCLUDING POLICE AND FIRE MOTOR VEHICLES AND EQUIPMENT AND THAT TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS WILL BE IMPOSED”

CITY OF EL PASO, TEXAS PROPOSITION B - STREETS

“THE ISSUANCE OF \$268,131,612 GENERAL OBLIGATION BONDS FOR STREET IMPROVEMENTS AND THAT TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS WILL BE IMPOSED”

CITY OF EL PASO, TEXAS PROPOSITION C – PUBLIC HEALTH

“THE ISSUANCE OF \$71,418,095 GENERAL OBLIGATION BONDS FOR PUBLIC HEALTH FACILITIES AND THAT TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS WILL BE IMPOSED”

CITY OF EL PASO, TEXAS PROPOSITION D – ANIMAL SERVICES

“THE ISSUANCE OF \$10,969,088 GENERAL OBLIGATION BONDS FOR ANIMAL SERVICES FACILITIES AND THAT TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS WILL BE IMPOSED”

SECTION 4: All resident qualified electors of the City shall be permitted to vote at such election, and on the day of the election, such electors shall vote at the polling place designated for the election precinct in which they reside. This election shall be held and conducted in accordance with the provisions of Texas Election Code and Texas Government Code, Chapter 1251, and to the extent required by law, all election materials and proceedings shall be printed in both English and Spanish.

SECTION 5: A substantial copy of this Ordinance, including a Spanish translation thereof, shall be posted (i) at City Hall not less than twenty-one (21) days prior to Election Day;

(ii) at three additional public places within the City not less than twenty-one (21) days prior to Election Day, (iii) in a prominent location at each polling place on Election Day and during early voting, and (iv) along with any sample ballot prepared for the election, in a prominent location on the City's internet website not less than twenty-one (21) days prior to Election Day. Notice of the election as required by the Texas Election Code and Chapter 1251 of the Texas Government Code, including a Spanish translation thereof, shall also be published on the same day in each of two successive weeks in a newspaper of general circulation in such City, the first of such publications to appear in such newspaper not more than thirty (30) days and not less than fourteen (14) full days prior to the day of the election

SECTION 6: In accordance with Texas Election Code, Section 3.009(b), as amended, the aggregate amount of outstanding principal of the City's debt obligations secured by ad valorem taxes as of the beginning of the City's 2018/2019 fiscal year, and as of the date of this Ordinance totaled \$1,345,785,000 and \$1,345,785,000, respectively; the aggregate amount of outstanding interest on the City's debt obligations secured by ad valorem taxes as of the beginning of the City's 2018/2019 fiscal year and as of the date of this Ordinance totaled \$740,079,250.76 and \$711,291,450.74, respectively; and the ad valorem debt service tax rate as of the date hereof for the City for the 2018/2019 fiscal year is \$0.2861 per \$100 of taxable assessed valuation. Based on the bond market conditions at the date of adoption of this Ordinance, the maximum net effective interest rate for any series of the bonds is estimated to be 4.5%. Such estimated maximum rate is provided as a matter of information and in accordance with the requirements of Texas law, but is not a limitation on the interest rate at which the bonds, or any series thereof, may be sold.

SECTION 7: This Ordinance hereby incorporates the provisions of the Contract, and to the extent of any conflict between this Ordinance and the Contract, the provisions of the Contract shall control. By incorporating all essential terms necessary for a joint election agreement, this Ordinance is intended to satisfy Section 271.002(d) of the Texas Election Code, as amended, without further action of the City Council. The Mayor, City Manager, City Clerk or other appropriate City official, is hereby authorized to correct, modify or change the information in this Ordinance and the attached Exhibits based upon the final form of ballot or final locations, dates and times agreed upon by the El Paso County Elections Administrator and the City as well as incorporate additional early voting locations as designated by the El Paso County Elections Administrator. Matters contained in this Ordinance relating to discretionary, procedural matters may be amended by approval of the City Manager, and procedural matters not established by this Ordinance will be established by resolution of City Council. The City Manager and City Clerk, in consultation with the City Attorney, are hereby authorized and directed to take any additional action necessary to comply with provisions of the Texas Election Code or other state and federal statutes and constitutions in carrying out the conduct of the election, whether or not expressly authorized herein.

SECTION 8: It is officially found, determined, and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.

SECTION 9: If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and this Council hereby declares that this Ordinance would have been enacted without such invalid provision.
