Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets of the El Paso city code, to add the north side of Rex Baxter Dr. from residential driveway 11405 to 11400, the penalty being as provided in section 12.84.010 and chapter 12.85 of the El Paso city code.

BACKGROUND / DISCUSSION:

A petition was submitted to Streets and Maintenance (SaM) by a resident to have parking restricted in the cul-de-sac on Rex Baxter Drive, west of Billie Marie. The request was made to restrict parking due to customers from a home-based business parking in the cul-de-sac, causing a nuisance in the area and inhibiting access to driveways. The results of the petition showed that the majority of the residents do not object to the proposed restriction.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III- PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE EL PASO CITY CODE, TO ADD THE NORTH SIDE OF REX BAXTER DRIVE FROM RESIDENTIAL DRIVEWAY 11405 TO 11400, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets.), is hereby amended to **add** the following paragraph:

381. The north side of Rex Baxter Drive from residential driveway 11405 to 11400.

Section 2. Except as herein amended, Title 12, Chapter 12.88 of the El Paso City Code shall remain in full force and effect.

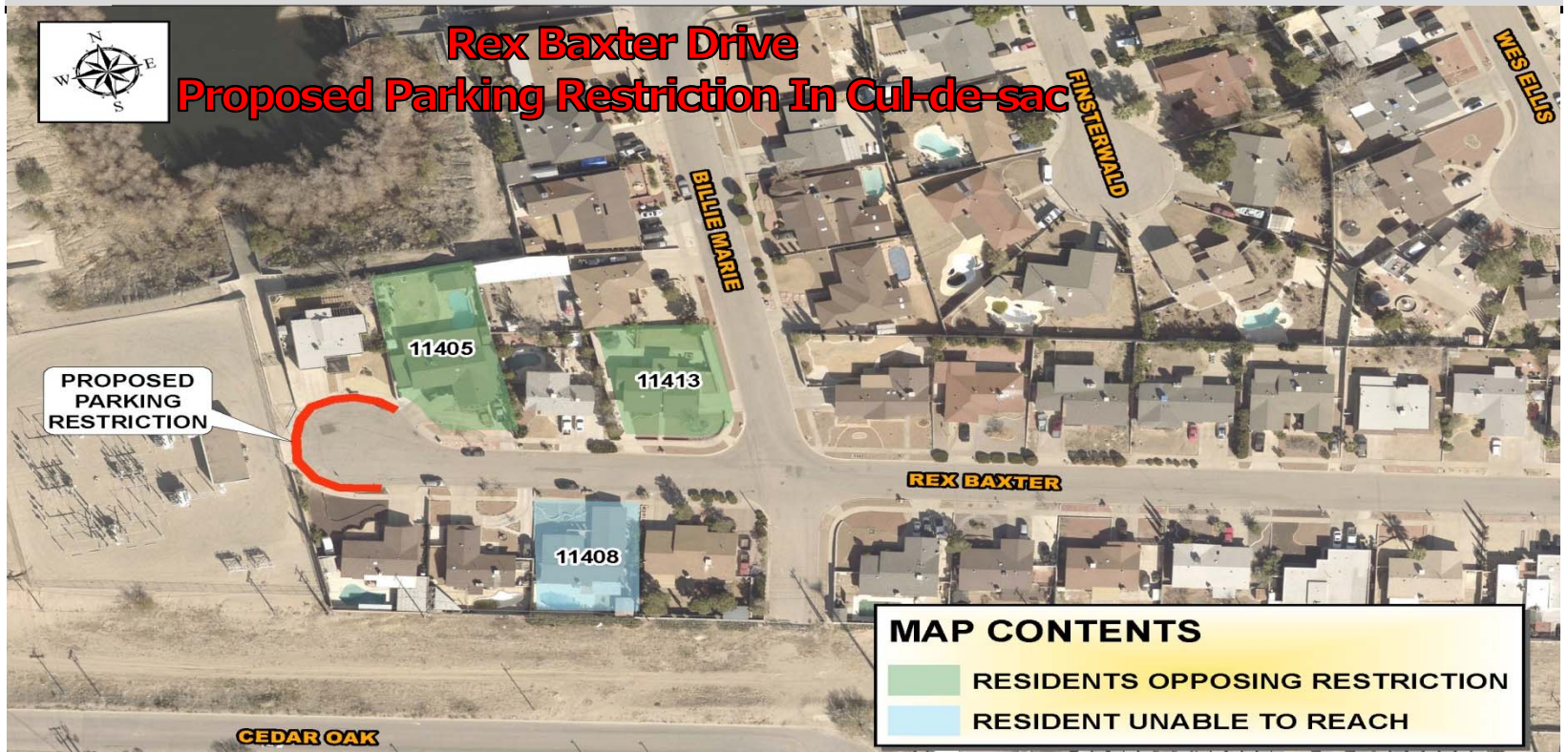
Staff recommends approval of proposed ordinance amendment to restrict parking in the cul-de-sac on Rex Baxter Drive for the following reasons:
