Goal 4 - Enhance El Paso's Quality of Life through Recreational, Cultural, and Educational Environments

SUBJECT:

An ordinance amending Title 13 (Streets, Sidewalks and Public Places), Chapter 13.24 (City Parks and Recreation Areas), Section 13.24.200 (Park and Recreation Facility use and fee authorization) of the El Paso City Code. In particular, Title, Chapter, Section 13.24.200-deleting subsection F, setting a cost recovery rate for sports complexes.

BACKGROUND / DISCUSSION:

City Council took action on October 30, 2018, to amend Title 13, Section 13.24, Subsection F, to establish a 75% cost recovery rate for sports complexes, and authorizing the department director to request schedule C adjustments. City Council also took action to amend the player fee of \$35/player/season.

Further review indicates that Subsection F should be deleted as the Director of the Parks and Recreation Department is already authorized to establish fees for the use of all sports complexes in Section 13.24.200 (B)(d) of the El Paso City Code to recover the cost of maintenance and operations.

With this ordinance change, City Council would annually authorize the fees in Schedule C.

WHEREAS, on October 16, 2018 City amended Chapter 13.24 allowing for the department director to establish a minimum seventy-five (75%) cost recovery rate for the maintenance and operation of any and all city sports complexes managed by the department through entrance fees as set by the city council through its annual budget resolution or other adopted resolution ("fee schedule"); and,

WHEREAS, the City desires to delete Section 13.24.200(F) since the Director of the Parks and Recreation Department is already authorized to establish fees for the use of all sports complexes in Section 13.24.200(B)(d) of the El Paso City Code to recover the cost of maintenance and operations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:
