That the City Manager be authorized to sign a two year On-Call Agreement for Professional Services to perform Construction Management services on a task by task basis by and between the City of El Paso and each of the following six (6) consultants:

1. CDM Smith, Inc.
2. CONSOR Engineers, LLC.
3. ECM International, Inc.
4. ESSCO International, Inc.
5. Paragon Project Resources, Inc.
6. Parkhill, Smith & Cooper

Each On Call Agreement will be for an amount not to exceed Nine Hundred Thousand and No/00 Dollars (\$900,000.00), and each agreement will include authorization for the City Engineer to approve additional Basic Services and Reimbursables for an amount not to exceed Fifty Thousand and No/100 Dollars (\$50,000.00) and authorization for the City Engineer to approve Additional Services for an amount not to exceed Fifty Thousand and No/100 Dollars (\$50,000.00) if the identified services are necessary for proper execution of identified project and if the increased amounts are within the appropriate budget identified for a project. In addition, the City Manager is authorized to establish the funding sources and make any necessary budget transfers and execute any and all documents necessary for execution of each On-Call Agreement.

BACKGROUND / DISCUSSION:

The on call agreement for professional services to perform construction management services assists the Capital Improvement Department as well as user departments to expedite and complete tasks for projects. City Council approved the previous two year on call agreement for architect services on July 12, 2016, this agreement expired on July 12, 2019. This new agreement will be for a two year term for an amount not to exceed \$900,000.00, with the authorization to increase contract capacity up to \$100,000.00 granted to the City Engineer.


