



Any violation of the conditions set forth herein will permit the Foundation to terminate any and all obligations with respect to any further distributions, whether made a part of this grant or any other approved grant from the Foundation and regardless of whether or not such distributions have been previously promised or pledged.
- 7. If the request is for the purchase of equipment, receipts as proof of purchase must be mailed to the Foundation. If the request is for general support or program related, a written report must be sent by email to <u>bjohnson@epcf.org</u> or mailed to our office on or before July 1, 2019. FAILURE TO REPORT BY THE DUE DATE TO THE FOUNDATION WILL RESULT IN YOUR ORGANIZATION BEING UNABLE TO BE CONSIDERED FOR A GRANT IN THE FUTURE.
