STRATEGIC GOAL: NO.7: Enhance and Sustain El Paso's Infrastructure Network

SUBJECT:

Discussion and action on the award of Solicitation No. 2018-1515R I-10 Mitigation Transit Service Neighborhood and Express to LULAC Project Amistad for an initial term of two (2) years for a total initial estimated award of \$1,989,507.00. The award is to include a one (1) year optional amount of \$994,753.50 for a total three (3) year award of \$2,984,260.50.

BACKGROUND / DISCUSSION:

Sun Metro started offering traffic mitigation for the west-side in May 2016 due to the start of the Go-10 and Border Expressway projects. The service was to be funded through FHWA-CMAQ grants obtained through the Regional MPO. The service consists of three neighborhood routes connecting to the Mesa Brio and/or the Westside terminal. Plus an express service from the Westside terminal to the Eastside (Cielo Vista) terminal. These routes were intended to mitigate traffic and reduce congestion and improve air quality. Sun Metro is enhancing efficiency by using a third-party to provide this service, formerly provided through the use of Sun Metro staff, units and maintenance.

SELECTION SUMMARY:

Solicitation was advertised on June 12, 2018 and June 19, 2018. The solicitation was posted on City Website on June 12, 2018. The email (Purmail) notification was sent out on June 14, 2018. Total of twelve (12) bidders were solicited; twelve (12) local vendors. Two (2) proposals were received; two (2) local vendors. An inadequate Competition Survey was conducted.
