SUBJECT:

That the City Manager be authorized to sign a Local Transportation Project Advance Funding Agreement by and between the City of El Paso and the State of Texas, acting by and through the Texas Department of Transportation, for the Bicycle Connectivity Infrastructure Improvements Phase II Project for the design and construction of bicycle facilities citywide, for an estimated total project cost of \$1,909,149.00, with an estimated City participation amount of \$134,589.00.

BACKGROUND / DISCUSSION:

The Bicycle Connectivity Phase II project includes the design and construction of bicycle facilities citywide to include the following: buffered bicycle lanes, conventional bicycle lanes, bicycle boulevards, shared lane markings and protected bicycle lanes. It is the second of two bicycle connectivity projects citywide. This advanced funding agreement with TxDOT allows for federal funding for design and construction. The City's required match for the Congestion Mitigation and Air Quality (CMAQ) funding is \$134,589.00.
