**SUBJECT:**

Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets) to amend by deleting subsections (50) and (256) and amending subsection (49), both sides of Concepcion Street. The penalty being provided in Chapter 1.08 (General Penalty) of the El Paso City Code.

**BACKGROUND / DISCUSSION:**

Texas Tech University Health Sciences Center (TTUHSC) El Paso submitted a letter requesting an extension of the existing NO PARKING ANYTIME restriction on Concepcion Street from Alameda Avenue to Alberta Avenue. TTUHSC believes that restricting parking will address their concerns of the possibility of parked vehicles impeding the flow of emergency vehicles due to the limited roadway width of 24' and the functionality of the street as a yield street when cars are parked on street.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III-PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO AMEND BY DELETING SUBSECTIONS (50) AND (256) AND AMENDING SUBSECTION (49), BOTH SIDES OF CONCEPCION STREET. THE PENALTY BEING PROVIDED IN CHAPTER 1.08 (GENERAL PENALTY) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III- Parking prohibited at all times on certain streets), Subsection 50 and 256, be deleted.

**Section 2.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III- Parking prohibited at all times on certain streets), Subsection 49 is hereby amended to read as follows:

49. Both sides of Concepcion Street from Rosa Avenue to Alameda Avenue.

**Section 3.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.


