That Schedule C, attached to the FY 2016 Budget resolution and effective September 1, 2015, shall be amended effective August 9, 2016, as set forth in Attachment A, to specify revised fees associated with amendments to El Paso City Code Title 6 and Chapter 14.16.

BACKGROUND / DISCUSSION:

On August 25, 2015, City Council unanimously carried to direct staff to review the Taxicab Ordinance and revise as needed or provide for a new ordinance to allow transportation network companies (TNC's) to operate legally in the City of El Paso, remove outdated language that no longer applies, remove overextensive requirements, and ensure compliance with accommodating disabled persons. On May 17, 2016, City Council discussed proposed revisions and directed that staff work with the taxicab and TNC industry to make the taxi industry thrive and be competitive, allow TNC's to operate and compete as well, level the playing field and possibly put forth incentives. Such review and consultation with the industry leaders resulted in a significant revision and change in context requiring movement of some portions of Title 6 to other more suitable locations within the Code.
