BACKGROUND / DISCUSSION:

City staff recommendation is to approve a revised scope and initial list of Trailhead projects funded by the 2012 Quality of Life Bond. Recently City staff has been working with the community to update and revise the existing scope of work for Trailhead Projects. Several trailhead projects were determined to be no longer applicable due to changing conditions in the field, including land ownership, connections to trail systems, and user support.

The Department conducted a field visit with interested trail users that refined the scope of initial trailheads identified in the original plan and added one additional trailhead. The revised prioritized list was presented to the Open Space Advisory Board, and Bond Overview Advisory Committee who all recommended approval and submittal to City Council.
