**ISMAEL LEGARRETA, P.E.** is presently the General Manager for Kasco Structures ( El Paso Machine and Steel Co. Inc.) and has been for the past 14 years. Ismael obtained his Bachelor of Science in Civil Engineering from the University of Texas at El Paso in 1986. He is licensed under the structural designation and has been practicing structural engineering since . Previously, he was the chief engineer and co-owner of Ramsey Steel Co. in El Paso.

His involvement in SEAoT includes being the local chapter President of the El Paso Chapter in 2009. Ismael's dedication to SEAoT lead to his being President of SEAoT in 2010 and Past President in 2011. During his term as President , he championed the SE Licensure Initiative by SEAoT. After his presidency , Ismael continued on the SEAoT board by chairing the Financial Health Committee for 2 years. Ismael currently serves as the alternate State Director for El Paso.
