STRATEGIC GOAL: No. 7: Enhance and Sustain El Paso's Infrastructure Network

SUBJECT:

An ordinance amending Title 12 (vehicles and traffic) chapter 12.88 (schedules), section 12.88.180 (no stopping or standing – tow away zone), of the El Paso City Code to delete paragraphs 72, 102 and 103, thereby allowing parking on north side of Main Drive between Campbell Street and Kansas Street; Main Drive from Oregon Street to a point 100 feet west, north side; and Main Drive from a point 100 feet west of Oregon Street to El Paso Street, both sides, the penalty being as provided in section 12.84.010 of the El Paso City Code.

BACKGROUND / DISCUSSION:

It was brought to the attention of Streets and Maintenance that residents had been cited for parking on Main Drive between Kansas and Campbell despite a lack of "No Parking" signage. Streets and Maintenance therefore recommends removal of the parking restrictions on Main Drive between Kansas and Campbell in anticipation of the placement of metered parking in this area. We also recommend removal of parking restrictions in the area between Oregon and El Paso due to a street vacation.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING – TOW AWAY ZONE), OF THE EL PASO CITY CODE, TO DELETE PARAGRAPHS 72, 102, AND 103, THEREBY ALLOWING PARKING ON NORTH SIDE OF MAIN DRIVE BETWEEN CAMPBELL STREET AND KANSAS STREET; MAIN DRIVE FROM OREGON STREET TO A POINT 100 FEET WEST, NORTH SIDE; AND, MAIN DRIVE FROM A POINT 100 FEET WEST OF OREGON STREET TO EL PASO STREET, BOTH SIDES, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), is hereby amended to delete the following paragraphs:

- 72. North side of Main Drive between Campbell Street and Kansas Street;
- 102. Main Drive from Oregon Street to a point 100 feet west, north side; and,
- 103. Main Drive from a point 100 feet west of Oregon Street to El Paso Street, both sides;

Section 2. Except as herein amended, Title 12, Chapter 12.88 of the El Paso City Code shall remain in full force and effect.




