### BACKGROUND/DISCUSSION:

As part of the FY 2010 budget process for the City of El Paso, the Mayor and Council undertook an extensive review of all city boards and commissions and made a series of decisions to sunset and/or merge existing boards with other similar likeness. As part of this process, the Public Utility Regulation Board is sunset and this section no longer applies to its members. The PTSES board is also being sunset and this action allows for its members to be exempt from this section since its members will be members of the City Plan Commission.

#### ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 2.04.040 (HOLDING OVER PROHIBITED) OF THE EL PASO CITY CODE, TO DELETE THE REFERENCE TO THE PUBLIC UTILITY REGULATION BOARD CONTAINED THEREIN AND TO EXEMPT THE MEMBERS OF THE PHOTOGRAPHIC TRAFFIC SIGNAL ENFORCEMENT SYSTEM ADVISORY BOARD FROM THE APPLICATION OF THE SECTION.

WHEREAS, the City Council is sunsetting and streamlining several of the boards and commissions of the City; and

WHEREAS, with the sunsetting of the Public Utility Regulation Board and the naming of the members of the City Plan Commission as the members of the Photographic Traffic Signal Enforcement System Advisory Board, it is necessary to amend the provisions of Section 2.04.040, for the proper application of this ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Section 2.04.040 of the El Paso City Code be amended as follows:

Section 2.04.040 Holding over prohibited.

When the term of office of any member of any city board or commission expires, the member shall continue to serve until his successor is appointed and qualified, or until thirty days have passed following the expiration of the term, whichever event occurs first. Any holding over past the thirty-day period is prohibited, and after that time a vacancy in the board shall exist and the former member shall have no power to vote or participate in board proceedings; but such vacancy shall not serve to reduce the number of members required for a quorum. This section shall not apply to boards or commissions created by Charter, joint agreement with other political subdivisions, or pursuant to state statute; or to officers, where state law would prohibit such disqualification; or to the photographic traffic signal enforcement system advisory board or the community development steering committee for citizen participation.

Section 2. Except as herein amended, Title 2 (Administration and Personnel), Chapter 2.04 (Boards, Commissions and Committees Generally) shall remain in full force and effect.
