SUBJECT:

APPROVE a Resolution amending lines 400, 633, and 635 of Schedule C attached to the FY 2020 Budget Resolution to adjust the fees charged for building permits and inspections. (All Districts)

BACKGROUND / DISCUSSION:

The 86th Legislature passed a bill, effective May 21, 2019, that prohibits municipalities from considering the value of a dwelling or the cost of constructing or improving a dwelling in determining the amount of a building permit or inspection fee required in connection with the construction or improvement of a residential dwelling which required the City to amend the fees in order to comply with the new law.

PRIOR COUNCIL ACTION:

On August 13, 2019, City Council approved a resolution amending Schedule C to establish a tiered system for residential building permit and inspection fees.

On June 11, 2019, City Council approved a resolution amending Schedule C to establish a flat fee of \$0.82 per square foot for residential building permits.
