**SUBJECT:**

An Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (schedule XIV – Speed Limits) Paragraph F (Thirty-Five Miles per Hour), of the El Paso City Code, to add a new location on Ventana Avenue, the penalty being as provided in Chapter 1.08 (General Penalty) of the El Paso City Code.

**BACKGROUND / DISCUSSION:**

The recommendation is for a speed limit sign ordinance, for the two-way newly opened road (east-west) connecting Tierra Este Road and Rich Beem Boulevard located within the Ventanas Subdivision. This ordinance will provide necessary speed limit signs essential for Ventana Avenue, a new collector arterial street.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV – SPEED LIMITS) PARAGRAPH F (THIRTY-FIVE MILES PER HOUR), OF THE EL PASO CITY CODE, TO ADD A NEW LOCATION ON VENTANA AVENUE, THE PENALTY BEING AS PROVIDED IN CHAPTER 1.08 (GENERAL PENALTY) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV – Speed Limits), Paragraph 12.88.150(F) (Thirty five miles per hour) is hereby amended to add the following location:

**12.88.150 F. Thirty five miles per hour:**

**Ventana Avenue**

**Section 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.


