BACKGROUND / DISCUSSION:

The Pollard Park Improvements project consists of providing all labor, equipment, material and incidentals to improve existing park in order to receive new play equipment, swing, turf, landscaping and ADA accessible on-street parking.

The Pollard Park Improvements Project consists of the installation of a new handicap accessible sidewalk, ramp, parking space and the demolition of existing curbing and the addition of accessible ramps and striping at the south end of Pollard Park on Pollard St. This is a minimum disturbance site with limited areas designated for construction. All existing plant material and mulch outside of the limits

of construction must be preserved and protected with fencing. The improvements to the park include standard concrete sidewalk and paving, new play equipment, metal canopy and swings, new engineered wood fibers, and bicycle racks. The existing rock and boulders will be reused. A new park rules sign and handicap parking sign will be installed. New sod will be installed after the removal of 12 inches of existing soil and the installation of 12 inches of new top soil and a new irrigation system will be included in this scope of work.

SCOPE OF WORK

Traffic Control Plan must be submitted and approved, if applicable. Contractor shall provide written approved documentation from the owner or operator of the waste site.


